A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THREE THOUSAND FIVE HUNDRED SIXTY-THREE DOLLARS (\$3,563) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES AND NINE HUNDRED SEVENTY-THREE DOLLARS (\$973) AS A CONTRIBUTION FROM THE 2010 ANCHORAGE POLICE DEPARTMENT OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE GRANTS FUND (231), ANCHORAGE POLICE DEPARTMENT, FOR THE CRASH DATA RETRIEVAL (CDR) TRAINING PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of THREE THOUSAND FIVE HUNDRED SIXTY-THREE DOLLARS (\$3,563), is appropriated from the State of Alaska, Department of Transportation and Public Facilities to the State Grants Fund (231), Anchorage Police Department for a CDR Training Grant.

Section 2. That the sum of NINE HUNDRED SEVENTY-THREE DOLLARS (\$973) is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2010 Anchorage Police Department Operating Budget as a contribution to the State Grants Fund (231) for a CDR Training Grant.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

The Municipality of Anchorage has received a grant from the State of Alaska in the amount of \$3,563 with a required local contribution of \$973 for a total program budget of \$4,536. This grant will provide funding for the continuation of a Crash Data Retrieval System program that has been utilized in serious traffic accident investigations for the past few years.

This Grant funding will be used to reimburse the cost for a sworn officer to attend annual Crash Data Retrieval System Training. The performance period of this grant is November 1, 2010 to September 30, 2011.
