A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING A GRANT FROM THE U.S. DEPARTMENT OF TRANSPORTATION, THROUGH THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES, FOR ONE HUNDRED THOUSAND DOLLARS (\$100,000) TO THE STATE DIRECT/FEDERAL PASS-THRU GRANTS FUND (231), PUBLIC TRANSPORTATION DEPARTMENT, AND A CONTRIBUTION OF TWO THOUSAND ONE HUNDRED NINETY-NINE DOLLARS (\$2,199) FROM THE AREAWIDE GENERAL FUND (101), PUBLIC TRANSPORTATION DEPARTMENT, TO THE STATE DIRECT/FEDERAL PASS-THRU GRANTS FUND (231), PUBLIC TRANSPORTATION DEPARTMENT, FOR EMPLOYMENT RELATED COORDINATED TRANSPORTATION SERVICES FOR LOW INCOME INDIVIDUALS WITHIN THE MUNICIPALITY OF ANCHORAGE.


THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That One Hundred Thousand Dollars (\$100,000) is hereby appropriated from the United States Department of Transportation, Federal Transit Administration, as a grant through the State of Alaska, Department of Transportation and Public Facilities, funding Job Access Reverse Commute (JARC) transportation services within the Municipality of Anchorage to the State Direct/Federal Pass-through Grants Fund (231), Department of Public Transportation.

Section 2. That Two Thousand One Hundred Ninety-nine Dollars (\$2,199) is appropriated from the Areawide General Fund (101), Public Transportation Department, as a contribution funding grant support by Municipal Central Service Agencies to the State Direct/Federal Pass-through Grants Fund (231), Department of Public Transportation.

Section 3. This resolution shall take effect immediately upon passage and approval.

Subject: APPROPRIATION OF A GRANT FROM THE U.S. DEPARTMENT OF TRANSPORTATION, THROUGH THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES, FOR ONE HUNDRED THOUSAND DOLLARS (\$100,000) TO THE STATE DIRECT/FEDERAL PASS-THRU GRANTS FUND (231), PUBLIC TRANSPORTATION DEPARTMENT, AND A CONTRIBUTION OF TWO THOUSAND ONE HUNDRED NINETY-NINE DOLLARS (\$2,199) FROM THE AREAWIDE GENERAL FUND (101), PUBLIC TRANSPORTATION DEPARTMENT, TO THE STATE DIRECT/FEDERAL PASS-THRU GRANTS FUND (231), PUBLIC TRANSPORTATION DEPARTMENT, FOR EMPLOYMENT RELATED COORDINATED TRANSPORTATION SERVICES FOR LOW INCOME INDIVIDUALS WITHIN THE MUNICIPALITY OF ANCHORAGE.

The Public Transportation Department of the Municipality of Anchorage has received notice of award of a Federal Transit Administration (FTA) 3037 Job Access Reverse Commute (JARC) grant through the State of Alaska, Department of Transportation and Public Facilities. The FTA requires recipients to distribute these funds within our community according to a locally developed and adopted Human Service Transportation Coordination Plan. The FTA gives specific guidance for elements that must be included in this plan as well as the public process that must include a broad range of stakeholder and interested parties. The most recent Anchorage Plan was adopted by Anchorage Metropolitan Area Transportation Study in May 2009.

This grant funds contracted employment related transportation services within the Municipality with emphasis on the Eagle River/Chugiak to Anchorage 'Connect' service. The beginning date for the grant is July 1, 2010 and the ending date is December 31, 2011. The required match of \$100,000 is provided through 'in-kind' matching from the 2010 and 2011 Operating Budgets in the General Fund (101), Public Transportation Department. Additionally, the Intragovernmental costs of \$2,199 for this project will be funded through a contribution from the Areawide General Fund (101), Public Transportation Department, to the State Direct/Federal Pass-thru Grants Fund (231), Public Transportation Department.
