THE ANCHORAGE ASSEMBLY RESOLVES:

<u>Section 1.</u> That the Mayor or Municipal Manager, or such other person as the Mayor or Municipal Manager designates, is authorized to execute and file applications on behalf of the Municipality of Anchorage with the State of Alaska to aid in the financing of planning assistance projects pursuant to section 5303 of the Urban Mass Transportation Act of 1964.

<u>Section 2</u>. That the Mayor or the Municipal Manager, or such other person as the Mayor or Municipal Manager designates, is authorized to execute and file with such applications an assurance or other document required by the United States Department of Transportation effectuating the purpose of Title VI of the Civil Rights Act of 1964.

<u>Section 3</u>. That the Mayor or the Municipal Manager, or such other person as the Mayor or Municipal Manager designates, is authorized to set forth and execute affirmative minority business policies in connection with this application's program of projects.

<u>Section 4</u>. That the Mayor or the Municipal Manager, or such other person as the Mayor or Municipal Manager designates, is authorized to furnish such additional information as the State of Alaska may require in connection with this application's program of projects.

<u>Section 5</u>. That the Mayor or the Municipal Manager, or such other person or persons as the Mayor or Municipal Manager designates, is authorized to enter into a Transfer of Responsibilities Agreement (TORA) between the State of Alaska, the Department of Transportation and Public Facilities for the financing of the Transit Planning Program.

<u>Section 6</u>. That the sum of two hundred ninety-two thousand one hundred fourteen dollars (\$292,114) is appropriated as a grant from the State of Alaska, the Department of Transportation and Public Facilities, when awarded, to the State Direct/Federal Pass-thru Grants Fund (231), Public Transportation Department, for the financing of the Transit Planning Program.

<u>Section 7</u>. That the sum of seventy-three thousand twenty-nine dollars (\$73,029) is appropriated as a contribution from the Areawide General Fund (101), Public Transportation Department, to the State Direct/Federal Pass-thru Grants Fund (231), Public Transportation Department, to serve as the required local match.

<u>Section 8</u>. This resolution shall take effect immediately upon passage and approval.

The Municipality of Anchorage has entered into a Transfer of Responsibilities Agreement (TORA) with the State of Alaska, Department of Transportation and Public Facilities accepting a grant to provide for Public Transportation Planning.

Under the provisions of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) Federal Transit Administration (FTA) planning grants are awarded to the State of Alaska. Following the grant award from FTA the State of Alaska, Department of Transportation and Public Facilities develops a TORA which 'passes through' FTA funds to the Municipality of Anchorage. The amount of this TORA using the 2010 Section 5303 apportionment for the transit planning program is \$292,114. The required local match for the 2010 program is \$73,029 and is to be funded from the Public Transportation Department's 2010 operating budget as a cash contribution to the grant.

The grant supports the continuing, comprehensive and cooperative transit planning activities by the Public Transportation Department described in the Anchorage Metropolitan Area Transportation Solutions (AMATS) Unified Planning Work Program (UPWP). This work includes comprehensive route structure analyses, review of system ridership and on-going People Mover planning issues. The period of performance will be from October 1, 2010 through December 31, 2011.
