The Municipality of Anchorage has entered into a standard agreement grant with the State of Alaska, Department of Transportation and Public Facilities MS/CVE under the Motor Carrier Safety Assistance Program.

The funding provided under this program will be used for the reimbursement of commercial vehicle inspections conducted in conjunction with commercial vehicle code enforcement. associated administrative costs and required equipment to enhance the capabilities of the inspection process. Through increased commercial vehicle safety inspections the residents of Anchorage will experience safer roads and reduced traffic accident injuries.

A special condition of this grant agreement is that the department provides matching funds. The total projected Municipal cost is \$688, which has been budgeted in the 2011 Police Department Operating Budget. This grant is being presented after the actual performance begin date of October 1, 2010 due to late notification by the grantor. The grant will end on September 30, 2011.
