

11 **THE ANCHORAGE ASSEMBLY RESOLVES:**

13 **Section 1.** That TWO HUNDRED FORTY-SEVEN THOUSAND TWENTY-ONE
14 DOLLARS (\$247,021), is appropriated from the State of Alaska, Department of
15 Transportation to the State Categorical Grants Fund (231), Anchorage Police
16 Department, for impaired driving enforcement.

18 **Section 2.** That FIVE THOUSAND FOUR HUNDRED THIRTY-TWO DOLLARS
19 (\$5,432) is appropriated from the Anchorage Metropolitan Police Service Area
20 Fund (151), 2011 Anchorage Police Department Operating Budget as a
21 contribution to the State Categorical Grants Fund (231), Anchorage Police
22 Department to fund intragovernmental charges.

24 **Section 3.** This resolution shall take effect immediately upon passage and
25 approval by the Anchorage Municipal Assembly.

18 vehicle costs associated with focused traffic assignments specifically targeted for

21 offenses, the citizens of Anchorage will experience safer roads and reduced traffic

22 accident injuries. This grant is intended to support focused enforcement during the

23 period April 1, 2011 through September 30, 2011.
