9 **Section 1.** The sum of TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) of general
10 obligation bond proceeds of the Municipality of Anchorage is hereby appropriated to the
11 Anchorage Police Department in the Anchorage Police Metropolitan Service Area CIP Fund (451)
12 for the purpose of providing police protection capital improvements within the Anchorage
13 Metropolitan Police Service Area as approved by voters in the election held April 5, 2011.

15 **Section 2.** This resolution shall be effective immediately upon passage and approval by the
16 Assembly.

SUBJECT: A RESOLUTION APPROPRIATING TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) FROM GENERAL OBLIGATION BOND PROCEEDS TO THE ANCHORAGE METROPOLITAN POLICE SERVICE AREA CAPITAL IMPROVEMENT PROGRAM FUND (451) TO PAY THE COSTS OF PUBLIC SAFETY FACILITIES AND CAPITAL IMPROVEMENT PROJECTS IN THE ANCHORAGE POLICE DEPARTMENT.

On February 1, 2011 the Anchorage Assembly approved an ordinance authorizing a general obligation bond proposition (AO 2011-14(S)) for the purpose of providing police protection capital improvements and related capital improvements within the Anchorage Metropolitan Police Service Area.

On April 5, 2011, voters approved the bond proposition for Anchorage Metropolitan Police Service Area in the amount of \$250,000. The bond provides funding to acquire, improve, expand, and equip a dispatch/computer room at the Anchorage Police Department Headquarters in the Anchorage Metropolitan Police Service Area. The accompanying Assembly Resolution appropriates voter-approved bond funds so that work on projects may begin.
