**A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING A GRANT OF FIVE MILLION FIFTY THOUSAND FOUR HUNDRED SIXTY-ONE DOLLARS (\$5,050,461) FROM THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY AND A CONTRIBUTION OF ONE HUNDRED ONE THOUSAND NINE DOLLARS (\$101,009) FROM THE ANCHORAGE FIRE SERVICE AREA FUND (131), ANCHORAGE FIRE DEPARTMENT 2011 OPERATING BUDGET, TO THE FEDERAL GRANTS FUND (241), ANCHORAGE FIRE DEPARTMENT, TO INCREASE FIRE AND EMERGENCY RESPONSE CAPABILITY THROUGH STAFFING OF TWENTY-SIX FIREFIGHTER AND THREE SAFETY OFFICER POSITIONS FOR TWENTY-FOUR MONTHS UTILIZING FUNDS PROVIDED UNDER THE FY 2010 STAFFING FOR ADEQUATE FIRE AND EMERGENCY RESPONSE (SAFER) GRANT PROGRAM.**

**THE ANCHORAGE ASSEMBLY RESOLVES:**

**Section 1:** That Five Million Fifty Thousand Four Hundred Sixty-one Dollars (\$5,050,461) is appropriated as a grant from the United States Department of Homeland Security to the Federal Grants Fund (241), Anchorage Fire Department, for FY 2010 Staffing for Adequate Fire and Emergency Response (SAFER) grant activities in the Anchorage Fire Department.


**Section 2:** That One Hundred One Thousand Nine Dollars (\$101,009) from the Anchorage Fire Service Area Fund (131), Anchorage Fire Department 2011 Operating Budget, is appropriated as a contribution to the Federal Grants Fund (241), for charges related to supporting the FY 2010 SAFER grant activities in the Anchorage Fire Department.

**Section 3:** This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

14 MONTHS UTILIZING FUNDS PROVIDED UNDER THE FY 2010  
15 STAFFING FOR ADEQUATE FIRE AND EMERGENCY RESPONSE  
16 (SAFER) GRANT PROGRAM.

18 The Municipality of Anchorage, Anchorage Fire Department has received from the United  
19 States Department of Homeland Security, FY 2010 Staffing for Adequate Fire and  
20 Emergency Response (SAFER) grant, funding to increase the department's fire and  
21 emergency response capability. Appropriation of this grant is requested to the Federal  
22 Grants Fund (241).

23  
24 Once appropriated, FY 2010 SAFER grant funds will be used to hire twenty-six  
25 firefighters and three safety officers for the Anchorage Fire Department to increase the  
26 frequency of compliance with National Fire Protection Association (NFPA) 1710 and 29  
27 Code of Federal Regulations (CFR) 1910 Occupational Safety and Health Standards as  
28 they pertain to Initial Full Alarm Assignment Capability and OSHA Respiratory Protection  
29 standards, respectively.

30  
31 The twenty-six firefighters and three safety officers hired under the FY 2010 SAFER  
32 grant funds must be retained for the grant performance period, after which time the  
33 Anchorage Fire Department is no longer required to fill these positions. During the  
34 twenty-four month performance period, the Anchorage Fire Department must also  
35 maintain its operational staffing level as of the grant award date February 11, 2011.

36  
37 FY 2010 SAFER grant funds will be administered by the Anchorage Fire Department.

39 Grant performance period is May 5, 2011 through May 4, 2013.

In line with Municipal accounting practices, the grant will be accounted for in the Federal Grants Fund (241), with the budget details as follows:
