11 **THE ANCHORAGE ASSEMBLY RESOLVES:**

13 **Section 1.** TWENTY-NINE THOUSAND EIGHT HUNDRED TWENTY-FIVE
14 DOLLARS (\$29,825), is appropriated from the State of Alaska, Department of
15 Transportation to the State Direct Federal Pass Through Grants Fund (231),
16 Anchorage Police Department for Seat Belt Enforcement.

18 **Section 2.** SIX HUNDRED FIFTY-SIX DOLLARS (\$656) is appropriated from
19 the Anchorage Metropolitan Police Service Area Fund (151), 2011 Anchorage
20 Police Department Operating Budget as a contribution to the State Direct Federal
21 Pass Through Grants Fund (231), Anchorage Police Department to fund
22 intragovernmental charges.

24 **Section 3.** This resolution shall take effect immediately upon passage and
25 approval by the Anchorage Municipal Assembly.

The grant from the State of Alaska, along with contributing funds from the Anchorage Police Department, will be used to pay officer overtime, benefits and vehicle costs associated with focused traffic assignments specifically targeted for enforcement of seat belt violations within the Municipality of Anchorage. Through increased awareness and enforcement of seat belt driving offenses, the citizens of Anchorage will experience safer roads and reduced traffic accident injuries. This grant is intended to support focused enforcement during the period April 1, 2011 through May 31, 2011.
