WHEREAS, the Real Estate Department purchased a parcel legally described as Tract B Muldoon Estates in 2006 with an inter-fund loan from Municipal Light & Power for \$3,688,437, for a five-year term with annual interest based upon the cash pool earnings rate plus 50 basis points; and

WHEREAS, the Real Estate Department is managing the assessment and cleanup of the Reeve Boulevard polychlorinated biphenyl (PCB) contaminated site previously used as a waste fill property; and

WHEREAS, the Parks and Recreation Department is managing the assessment and cleanup of the Kincaid Park Biathlon Range land remediation; now, therefore,

THE ANCHORAGE ASSEMBLY RESOLVES:

<u>Section 1.</u> The sum of Three Million Ninety-six Thousand Seven Hundred Eighty-two dollars (\$3,096,782) is hereby appropriated from the Areawide General Fund (101) fund balance to the Areawide General Fund (101) 2011 Operating Budget, to be used as a contribution to the Areawide General Capital Improvement fund (401) for the repayment of an inter-fund loan to Municipal Light and Power in the Real Estate Department.

Alaska Greenhouse Property Acquisition - \$3,096,782

In 2006, the Assembly approved (AO 2006-149(S)) as a \$3,688,437 inter-fund loan from ML&P to purchase the former Alaska Greenhouse property (Tract B, Muldoon Estates Subdivision). Repayment terms were specified in AM 799-2006, that required full payment within five years and payment of annual interest. The final payment to ML&P is due October 25, 2011. The first principal re-payment was made in December 2010. The requested appropriation will pay off the loan.

Reeve Boulevard Remediation - \$750,000

In 2008, the presence of PCBs exceeding applicable clean-up levels was discovered in the soil on the Reeve Boulevard Site (Parcel 3, Tract B, Municipal Industrial Subdivision Site), which is owned by the Municipality. The soil was transported to the site by and under the supervision of potentially responsible third parties. The

presence of the PCBs was reported to the Alaska Department of Environmental Conservation (ADEC) and the Environmental Protection Agency (EPA). The Municipality is working with ADEC and the EPA on proper characterization and remediation of the site. The Municipality also is pursuing its rights and remedies against third parties.

Kincaid Park Remediation - \$700,000

Kincaid Project Group, Inc. (KPG), an Alaska nonprofit corporation is making improvements within Kincaid Park, which is owned by the Municipality of Anchorage. In 2008 during the course of improvements, one or more of KPG's contractors disturbed lead-contaminated soils at the site of a former biathlon range. The EPA issued a notice of violation to Anchorage. As owner of the Park, the Municipality is a responsible party and is working with the other responsible parties, DEC and EPA, to satisfactorily resolve the violation. Remediation costs are estimated between \$600,000 and \$1.1 million, plus additional legal costs associated with attempting to obtain reimbursement from KPG and the other responsible parties. The requested funding will enable remediation work to get underway. Should additional funds be required and no alternate funding sources are available, a second appropriation request will be made at that time.
