A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING FIFTEEN THOUSAND EIGHT HUNDRED THIRTY-FOUR DOLLARS (\$15,834) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES AND NINE THOUSAND NINE HUNDRED FORTY-EIGHT DOLLARS (\$9,948) AS A CONTRIBUTION FROM THE 2011 ANCHORAGE POLICE DEPARTMENT OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE GRANTS FUND (231), ANCHORAGE POLICE DEPARTMENT, FOR THE IACP DRUG RECOGNITION EXPERT TRAINING CONFERENCE GRANT PROGRAM.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. That the sum of FIFTEEN THOUSAND EIGHT HUNDRED THIRTY-FOUR DOLLARS (\$15,834), is appropriated from the State of Alaska, Department of Transportation and Public Facilities to the State Grants Fund (231), Anchorage Police Department for an IACP Drug Recognition Expert Training Conference Grant.

Section 2. That the sum of NINE THOUSAND NINE HUNDRED FORTY-EIGHT DOLLARS (\$9,948) is appropriated from the Anchorage Metropolitan Police Service Area Fund (151), 2011 Anchorage Police Department Operating Budget as a contribution to the State Grants Fund (231) for an IACP Drug Recognition Expert Training Conference Grant.

Section 3. This resolution shall take effect immediately upon passage and approval by the Anchorage Municipal Assembly.

The Municipality of Anchorage has received a grant from the State of Alaska in the amount of \$15,834 with a required local contribution of \$9,948 for a total program budget of \$25,782. This grant will provide funding for six Drug Recognition Expert trained officers to attend the FY2011 IACP Drug Recognition Expert Training Conference in Montreal, Quebec, Canada.

This Grant funding will be used to reimburse the cost for six sworn officers to attend the training conference to maintain current certifications. The performance period of this grant is July 18, 2011 to July 21, 2011.
