16 Police Department for a 37<sup>th</sup> Annual International Traffic Records Forum Grant.



**Subject:** A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING THREE THOUSAND TWO HUNDRED SEVENTY-FOUR DOLLARS (\$3,274) FROM THE STATE OF ALASKA, DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES AND EIGHT HUNDRED NINETY-TWO DOLLARS (\$892) AS A CONTRIBUTION FROM THE 2011 ANCHORAGE POLICE DEPARTMENT OPERATING BUDGET, ANCHORAGE METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE STATE GRANTS FUND (231), ANCHORAGE POLICE DEPARTMENT, FOR THE 37<sup>th</sup> ANNUAL INTERNATIONAL TRAFFIC RECORDS FORUM GRANT PROGRAM.

The Municipality of Anchorage has received a grant from the State of Alaska in the amount of \$3,274 with a required local contribution of \$892 for a total program budget of \$4,166. This grant will provide funding for a Traffic Unit Representative to attend the 37<sup>th</sup> Annual International Traffic Records Forum in Charlotte, NC in July of 2011.

This Grant funding will be used to reimburse the cost for the Traffic Unit Clerk to attend the forum to increase efficiency in maintaining traffic records and to more effectively utilize data captured to implement action plans. The performance period of this grant is July 30, 2011 to August 4, 2011.
