9 **WHEREAS**, the Glen Alps SA is authorized to contribute tax revenues from the 2011

13 **WHEREAS**, there is \$40,000 approved in the 2011 General Government Operating Budget,
14 Glen Alps SA Fund (105) available as a contribution of tax revenues to the Miscellaneous
15 Capital Project/Pass-Thru Capital Improvement Program Fund (409) for road and drainage
16 capital improvement projects within the Glen Alps SA in the Public Works Department,

21 **Section 1.** The sum of a Forty Thousand Dollar (\$40,000) contribution of tax revenues
22 approved in the 2011 General Government Operating Budget, Glen Alps SA Fund (105) is
23 hereby appropriated to the Miscellaneous Capital Project/Pass-Thru Capital Improvement
24 Fund (409) for road and drainage capital improvement projects within the Glen Alps SA in
25 the Public Works Department, Administration Division.

28 the Anchorage Municipal Assembly.

SUBJECT: A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING A FORTY THOUSAND DOLLAR (\$40,000) CONTRIBUTION APPROVED IN THE 2011 GENERAL GOVERNMENT OPERATING BUDGET FROM THE GLEN ALPS SERVICE AREA (SA) FUND (105) TO THE MISCELLANEOUS CAPITAL PROJECT/PASS-THRU CAPITAL IMPROVEMENT PROGRAM FUND (409) FOR ROAD AND DRAINAGE IMPROVEMENT PROJECTS WITHIN THE GLEN ALPS SERVICE AREA (SA) IN THE PUBLIC WORKS DEPARTMENT, ADMINISTRATION DIVISION.

The attached Resolution appropriates to the Miscellaneous Capital Project/Pass-Thru Fund (409) a \$40,000 contribution of tax revenues approved in the Public Works Department, Administration Division, 2011 General Government Operating Budget, from the Glen Alps SA Fund (105) for road and drainage capital improvement projects within the Glen Alps SA in the Public Works Department, Administration Division.

AMC 27.30.190(B) in part states, "The Glen Alps SA may also provide for road maintenance/reduction and/or capital improvements with funds generated from a levy not to exceed 0.50 mill." The maximum levy of 2.75 mills was established in 2004 by the qualified voters within the Glen Alps SA. The Glen Alps SA Board of Supervisors has determined that it is reasonable and prudent to contribute to the capital fund as a method of accumulating funds for major road and drainage improvements, including acquiring needed public rights-of-way.

The Glen Alps SA Board of Supervisors requests that the Assembly approve and adopt the attached resolution.
