13 **Section 1.** THIRTY-ONE THOUSAND ONE HUNDRED EIGHTY-FIVE
14 DOLLARS (\$31,185), is appropriated from the State of Alaska, Department of
15 Transportation to the State Direct Federal Pass Through Grants Fund (231),
16 Anchorage Police Department for Seat Belt Enforcement.



14 The grant from the State of Alaska, along with contributing funds from the

15 Anchorage Police Department, will be used to pay officer overtime, benefits and

16 vehicle costs associated with focused traffic assignments specifically targeted for

17 enforcement of seat belt violations within the Municipality of Anchorage. Through

18 increased awareness and enforcement of seat belt driving offenses, the citizens of

19 Anchorage will experience safer roads and reduced traffic accident injuries. This

20 grant is intended to support focused enforcement during the period January 10,

21 2012 through March 31, 2012.
