11 THE ANCHORAGE MUNICIPAL ASSEMBLY RESOLVES:

13 Section 1. That the sum of THIRTEEN THOUSAND DOLLARS (\$13,000), is  
14 appropriated from the State of Alaska, Alaska Police Standards Council to the  
15 State Grants Fund (231), Anchorage Police Department, for a HEPA Filter  
16 Replacement grant.



18 Section 2. That the sum of TWO HUNDRED EIGHTY-SIX DOLLARS (\$286),  
19 is appropriated from the Anchorage Metropolitan Police Service Area Fund  
20 (151), 2012 Anchorage Police Department Operating Budget as a contribution to  
21 the State Grants Fund (231), Anchorage Police Department.

3 **Subject:** A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE  
4 APPROPRIATING THIRTEEN THOUSAND DOLLARS (\$13,000)  
5 FROM THE STATE OF ALASKA, ALASKA POLICE STANDARDS  
6 COUNCIL AND TWO HUNDRED EIGHTY-SIX DOLLARS (\$286) AS  
7 A CONTRIBUTION FROM THE 2012 ANCHORAGE POLICE  
8 DEPARTMENT OPERATING BUDGET, ANCHORAGE  
9 METROPOLITAN POLICE SERVICE AREA FUND (151) TO THE  
10 STATE GRANTS FUND (231) ANCHORAGE POLICE  
11 DEPARTMENT, FOR THIS HEPA FILTER REPLACEMENT  
12 GRANT.

14  
15 The Alaska Police Standards Council has provided funding for replacement of  
16 HEPA Filters at the Anchorage Police Department Training Facility. This grant is  
17 intended to offset a portion of annual HEPA Filter replacement costs in 2012.  
18

19 Funding will be used to partially reimburse the cost of replacement HEPA Filters  
20 that ensure adequate lead filtration of the internal Training Center areas, as well  
21 as the surrounding neighborhood. These 99.97% efficient filters guard against  
22 airborne lead contamination.  
23

24 A special condition of this grant is that the department provides matching funds.  
25 The total projected Municipal cost is \$286, which has been budgeted in the 2012  
26 Police Department Operating Budget. This grant is intended to support filter  
27 replacement during the period January 1, 2012 through December 31, 2012.
