The Community Development Department requests the re-appropriation of Eight Thousand Five Hundred Twenty Dollars (\$8,520) in unused fund contributions previously appropriated from the Historic Preservation Fund (740) to the Community Development Department Operating Budget Areawide General Fund (101) as approved by the Assembly under AR No. 2011-150/AM 300-2011 on May 24, 2011 for Oscar Anderson House Museum curator services back to Historic Preservation Fund (740) to be utilized for future historic preservation projects. Although procurement of curator services for the Oscar Anderson House Museum did qualify as an approved use of historic preservation funds, expenditures such as these are considered operating expenses which had to be incurred in an operating budget outside of the capital designated Historic Preservation Fund (740). As stated in Section 2 of AR No. 2011-150: "Any portion of this appropriation which is not used to support the operation of the Oscar Anderson House Museum by December 31, 2011 shall be re-appropriated back to the Historic Preservation Fund (740)."
