A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING A GRANT IN THE AMOUNT OF SIXTY THOUSAND THREE HUNDRED FORTY DOLLARS (\$60,340) FROM THE STATE OF ALASKA, DEPARTMENT OF PUBLIC SAFETY, ALASKA STATE TROOPERS OFFICE AND APPROPRIATING TWO THOUSAND NINE HUNDRED FIFTY-ONE DOLLARS (\$2,951) AS A CONTRIBUTION FROM THE DEPARTMENT OF LAW OPERATING BUDGET, AREAWIDE GENERAL FUND (101), TO THE STATE CATEGORICAL GRANTS FUND (231), FOR AN ANTI-GANG PROSECUTOR.

WHEREAS, the State of Alaska offered the Department of Law a grant for administration of the State of Alaska, Department of Public Safety, Alaska State Troopers (SOA, DPS/AST) Anti-Gang Program; and

WHEREAS, the Department of Law agrees to administer the SOA, DPS/AST Anti-Gang Program to meet the goals of both state and local interests, provided State funding is available; now therefore,

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. The sum of SIXTY THOUSAND THREE HUNDRED FORTY DOLLARS (\$60,340) is hereby appropriated from the State of Alaska, Department of Public Safety, to the State Categorical Grants Fund (231) for administration of the SOA, DPS/AST Anti-Gang Program in the Department of Law.

<u>Section 2.</u> The sum of TWO THOUSAND NINE HUNDRED FIFTY-ONE DOLLARS (\$2,951) is hereby appropriated from the 2012 Department of Law Operating Budget (Fund 101) as a matching contribution to the State Categorical Grants Fund (231) for the purpose of paying IGCs.

<u>Section 3.</u> This resolution shall be effective immediately upon its passage and approval by the Assembly.

A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING A GRANT IN THE AMOUNT OF SIXTY THOUSAND THREE HUNDRED FORTY DOLLARS (\$60,340) FROM THE STATE OF ALASKA, DEPARTMENT OF PUBLIC SAFETY, ALASKA STATE TROOPERS OFFICE AND APPROPRIATING TWO THOUSAND NINE HUNDRED FIFTY-ONE DOLLARS (\$2,951) AS A CONTRIBUTION FROM THE DEPARTMENT OF LAW OPERATING BUDGET, AREAWIDE GENERAL FUND (101), TO THE STATE CATEGORICAL GRANTS FUND (231), FOR AN ANTI-GANG PROSECUTOR.

The State of Alaska has approved a grant to be administered by the Department of Law funding one position: an Anti-Gang Prosecutor. The grant partially offsets the costs of one position. The attached resolution appropriates the 2012 grant from the State of Alaska, Department of Public Safety, Alaska State Troopers (SOA, DPS/AST) to fund the program.

Former U.S. Attorney, now U.S. District Court Judge Timothy Burgess, proposed a partnership between the Municipality of Anchorage and the Office of the U.S. Attorney to help combat gang-related crimes. At Burgess' invitation, the Municipality assigned the program to the U.S. Attorney's office. The program staff is specially trained in prosecution under federal laws, focusing primarily on gang-related crimes. Gang members prosecuted under federal law typically are processed more quickly, with more severe consequences, than under state law, removing gang members from Anchorage streets.
