WHEREAS, Bistro 907 LLC has made an application with the Alcoholic Beverage Control (ABC) Board and has paid the required fee for a Renewal of a Restaurant/Eating Place Liquor License #4970, to be used for Café Croissant, located at 3002 Spenard Road, Anchorage, Alaska; and

WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on January 19, 2012 and has determined that the last day for the Assembly to file a protest is March 19, 2012; and

WHEREAS, the Assembly Meeting on March 13, 2012 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

2. There are taxes owing to the Municipality of Anchorage in the amount of **\$1,502.40**.

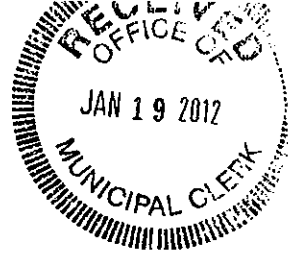
WHEREAS, protest by the Assembly is in order pending Municipal Clerk confirmation that outstanding items required for this location have been completed;
