WHEREAS, Gatling's Steakhouse LLC has made an application with the Alcoholic Beverage Control (ABC) Board and has paid the required fee for a New Restaurant/Eating Place Liquor License # 5119 and Restaurant Designation Permit, to be used for Gatling's Steakhouse, located at 21426 Old Glenn Hwy , Chugiak, Alaska; and

WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on January 23, 2012 and has determined that the last day for the Assembly to file a protest is March 23, 2012 and

WHEREAS, the Assembly Meeting on March 13, 2012 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

1. No ABC Board violations and/or incidents that would lead to an ABC Board violation;
2. No taxes owing to the Municipality of Anchorage;
3. Municipal Health and Human Services approval **has not** been received;
4. Administrative Site Plan Review, required by AMC 21.50.500, **has not been completed**;
5. Approval from the Building Safety Department **has been received**; and

WHEREAS, protest by the Assembly is in order pending Municipal Clerk confirmation that outstanding items required for this location have been completed;

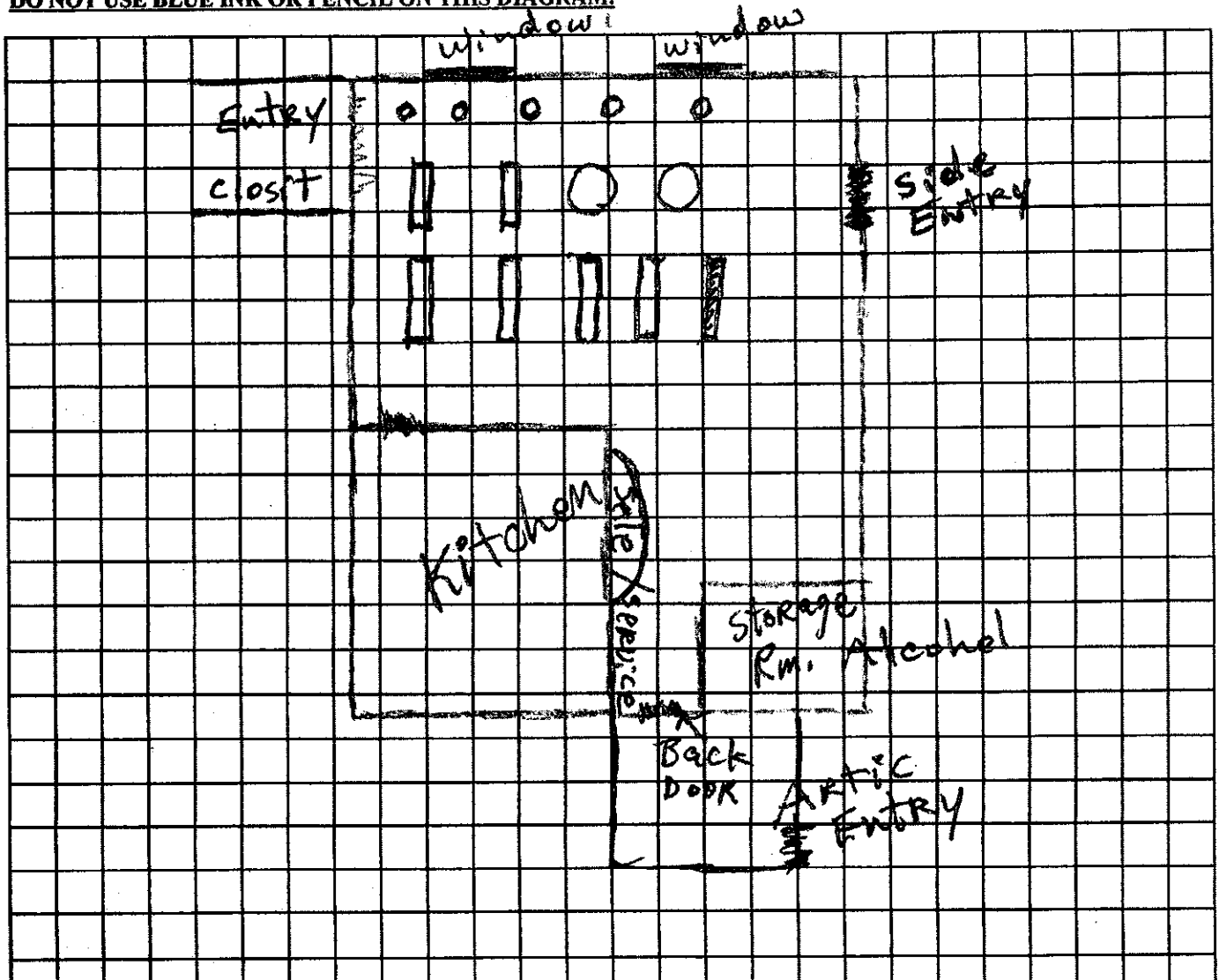
