A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY STATING ITS PROTEST REGARDING THE RENEWAL OF A BEVERAGE DISPENSARY/TOURISM LIQUOR LICENSE #4440 FOR BARRATT INN MGT CO LLC dba CRAVE BAR & GRILL, LOCATED AT 4616 SPENARD ROAD, AND AUTHORIZING THE MUNICIPAL CLERK TO TAKE CERTAIN ACTION.

WHEREAS, Barratt Inn MGT Co LLC has made an application with the Alcoholic Beverage Control (ABC) Board and has paid the required fee for a Renewal of a Beverage Dispensary Tourism Liquor License #4440, to be used for Crave Bar & Grill, located at 4616 Spenard Road, Anchorage, Alaska; and

WHEREAS, the Assembly must enter any protest to the ABC Board within 60 days following receipt of the application; and

WHEREAS, the Anchorage Municipal Clerk received a copy of this application on January 19, 2012 and has determined that the last day for the Assembly to file a protest is March 19, 2012; and

WHEREAS, the Assembly Meeting on March 13, 2012 is the last scheduled regular meeting of the Anchorage Assembly prior to the expiration of the protest period; and

WHEREAS, the Municipal Clerk reports the following status concerning this location:

1. Any ABC Board violations and/or incidents are on file that would lead to an ABC Board violation are attached;
2. There are taxes owing to the Municipality of Anchorage in the amount of **\$3,849.90.**

WHEREAS, protest by the Assembly is in order pending Municipal Clerk confirmation that outstanding items required for this location have been completed;

NOW, THEREFORE, THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1. The Anchorage Assembly hereby enters its **PROTEST** for a Renewal of Beverage Dispensary/Tourism # 4440 until this condition is met:

- Taxes owing to the Municipality of Anchorage in the amount of \$3,849.90 are paid in full.

Section 3. The Anchorage Assembly hereby authorizes the Municipal Clerk, upon Municipal Clerk confirmation that all conditions in Section 1 have been met, to provide written notification to the Alcoholic Beverage Control Board that this protest by the Anchorage Assembly is lifted, without further action by the Assembly.

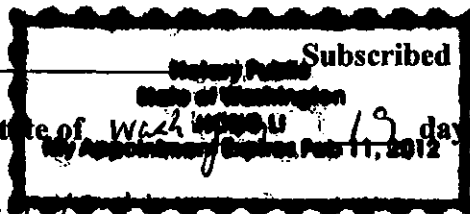
