11 THE ANCHORAGE ASSEMBLY RESOLVES:

13 **Section 1.** The sum of EIGHTY-TWO THOUSAND FOUR HUNDRED TWENTY-SIX  
14 DOLLARS (\$82,426) is hereby appropriated as grant awarded by the State of Alaska, Institute of  
15 Museum and Library Services, Division of State Libraries to the Anchorage Public Library  
16 Department, State Grants Fund (231) and ONE THOUSAND TWO HUNDRED FORTY- TWO  
17 DOLLARS (\$1,242) is hereby appropriated as a contribution from the Anchorage Public Library  
18 Operating Budget, Areawide General Fund (101) for the 800# Interlibrary Loan and Reference  
19 Backup Services.

21 **Section 2.** That this resolution shall take effect immediately upon passage and approval.

8 (231), AND APPROPRIATING ONE THOUSAND TWO HUNDRED FORTY-  
9 TWO DOLLARS (\$1,242) AS A CONTRIBUTION FROM THE ANCHORAGE  
10 PUBLIC LIBRARY OPERATING BUDGET, AREAWIDE GENERAL FUND (101)  
11 FOR 800# INTERLIBRARY LOAN AND REFERENCE BACKUP SERVICES

13 Notification has been received that the Anchorage Public Library is awarded an \$82,426 grant  
14 from the State of Alaska, Institute of Museum and Library Services, Division of State Libraries, for  
15 the purpose of funding the Interlibrary Loan and Reference Backup Services. The Municipal  
16 contribution of \$1,242 required for the 800# Interlibrary Loan Grant will come from the 2012  
17 Library operating budget within Areawide General Fund.  
18

19 The 800# Interlibrary Loan and Reference Backup Services grant continues funding to provide  
20 toll-free interlibrary loan handling services for Alaska's public libraries, school/community libraries  
21 and qualified school districts. It also provides continued funding for backup reference service to  
22 all public and school/community libraries in Alaska, and qualified school districts. These grant  
23 funds cover the grant period of October 1, 2011 through June 30, 2012.
