12 WHEREAS, Anchorage Skates! has donated the raised funds to the Municipality of
13 Anchorage Parks and Recreation Department for the purpose of defraying the annual
14 cost of maintaining the skating oval at Cuddy Family Midtown Park; now, therefore,

16 THE ANCHORAGE ASSEMBLY RESOLVES:

18 **Section 1.** The sum of Ten Thousand Dollars (\$10,000) is hereby appropriated
19 from the Anchorage Skates! to the Miscellaneous Operational Grants Fund (261)
20 Parks and Recreation Department for the purpose of defraying the annual cost of
21 maintaining the skating oval at the Cuddy Family Midtown Park.

23 **Section 2.** This resolution shall be effective immediately upon passage and
24 approval by the Assembly.
