II. CALL TO ORDER

III. ACTION SUMMARY

A. Regular Meeting of March 26, 2014

Commissioner Nyman moved to approve the March 26, 2014 minutes.

Commissioner Sinnott seconded.

The minutes for the March 26, 2014 meeting were approved as written.

IV. NEW BUSINESS

A. Northern Access to U-Med District – State of Alaska Road Project

Staff introduced the discussion and explained that the Commission attempts to receive briefings and offer relevant comments on road and other large-scale projects during the scoping and design phases, rather than closer to the permitting and final design timeframes. This approach enables the Commission's findings to positively contribute to project designs that mitigate for and address wildlife impacts and relevant hydrology concerns.

Patrick Whitesell with DOWL HKM introduced the topic and provided information on the planning and design process to date. The planning effort includes a seven-party MOU and an executive steering committee. The MOU parties signed a resolution of support of the design and planning process to this point. Key drivers for the design include challenging environmental conditions, major utility conflicts in the corridor, and a fixed budget for design and construction. DOWL HKM presented a concept alignment, which includes: three roundabouts, a new signal at Northern Lights and Bragaw, three overhead/grade-separated pedestrian crossings, two travel lanes for 30 mph, and an 80' ROW with an urban section and curb and gutter. The planning team felt that the 30-mph travel speed, the extensive lighting plans, and associated site-distance clearing contribute to minimizing wildlife conflicts.

Commissioners asked clarifying questions about design and potential impacts to local hydrology and new outfalls for collected stormwater in the new roadway. The Commission asked the team to consider wildlife crossings on elevated sections and to minimize fill in wetlands and using wetlands as treatment for runoff before it enters ponds and Mosquito Lake.

V. OLD BUSINESS

Commissioner Kent moved to adopt draft WNRC Resolution No.2014-02, which recommends that the municipal Planning Division modify Title 21 to restrict certain fence types that are known wildlife hazards.

Commissioner Nyman seconded.

The motion to adopt WNRC Resolution No. 2014-02 passed unanimously.
