#### V. OLD BUSINESS

### A. WNRC 2016-01 - AWWU Fish Creek Sewer Trunk Project Fencing Discussion

The Commission discussed its ideas on this request for recommendations from the Anchorage Water and Wastewater Utility (AWWU) concerning the fencing issues and conditions at their project site in the Fish Creek Estuary. AWWU offered a graphic depiction of existing and future fence features at the project site and along the Alaska Railroad (ARR) property line.

There are existing and potential future conflicts in this location for wildlife and the future trail corridor planned in concept along the ARR property line. The Commission continues to have general concerns about the use of fencing to demarcate linear projects like major road or ARR features, which create wildlife crossing conflicts. The suggestion was made at the prior meeting that a moose gate or other crossing feature be designed into the fence project. The Commission determined that a moose gate here in this site's circumstances is inappropriate. It was also stated that vegetation within the ARR corridor, which might be isolated between existing and future fence lines, is what would further attract moose and make conflicts worse. The Commission decided that it should convey a memo to AWWU on this subject with the following items:

- Vegetation is the basis for attracting more moose into and through the sewer easement ARR corridor.
- The ARR and the Municipality should consider factoring in and constructing a passageway, most likely a separated crossing (e.g., underpass) of the ARR ROW, for a future trail, which might function for moose movements.
- The Commission does not recommend a moose gate here.

#### B. Anchorage Bowl Land Use Plan Map

Tom Davis from the Long-Range Planning Division continued discussing features of the Anchorage Bowl Land Use Plan Map draft that are relevant to the Commission. Items he hopes the Commission will find of interest are the Greenway Supported Development Corridors, the Natural Assets Map, and the Public Facility/Natural Areas concepts, which focus on important natural areas that could become future major facilities, like parcels at the Airport perimeter.

Tom is asking for the Commission to focus on these and offer findings and recommendations when the public hearing draft comes out. He hope to receive these via a resolution in general support.
