# B. Special Meeting of October 12, 2016

#### **IV. NEW BUSINESS**

### A. MOA-Watershed Management Section, Annual Update

Kristi Bischofberger, Manager of the Project Management and Engineering Department's Watershed Management Section (WMS) gave an overview of her Section's activities for the past year. The Section continues to implement and administer the Municipality's federal/state Alaska Permit (APDES) with decreasing funding. WMS is updating its spill plans, including response and monitoring protocols. They operate an active deicing and anti-icing program on roads and parking lots, and focus on calcium chloride reductions, especially relative to runoff to streams and waterbodies. This is both a safety and environmental issue. WMS is working on a management approach to maximize the efficiency of use for this product. The MOA continues to use magnesium chloride.

WMS has contributed to the Anchorage Hazard Mitigation Plan, draft #2. The drainage section of the MOA Design Criteria Manual is out for public hearing and approval. And WMS continues to monitor and manage the groundwater seepage issue at Merrill Field and DeBarr. The Mayor's Office has shown renewed interest in a new areawide stormwater utility, but funding is a roadblock for now.

WMS will hold its annual meeting on March 29.

# V. OLD BUSINESS

# A. Anchorage 2040 Land Use Plan Map Discussion

Commissioner Billman summarized that the Commission had some issues with the wildlife habitat data and summary information on the Anchorage 2040 Land Use Plan's story background maps. The map may have some inconsistencies or improper depictions of certain wildlife information that may confuse or improperly inform future land use decisions, especially relative to bear data on the Hillside/State Park interface. Tom Davis, the map author, described the data, its sources, and how it informed the Draft 2040 Land Use Plan. Given the absence of several Commissioners from this meeting, it was agreed that this discussion will be added to the next regular meeting.
