

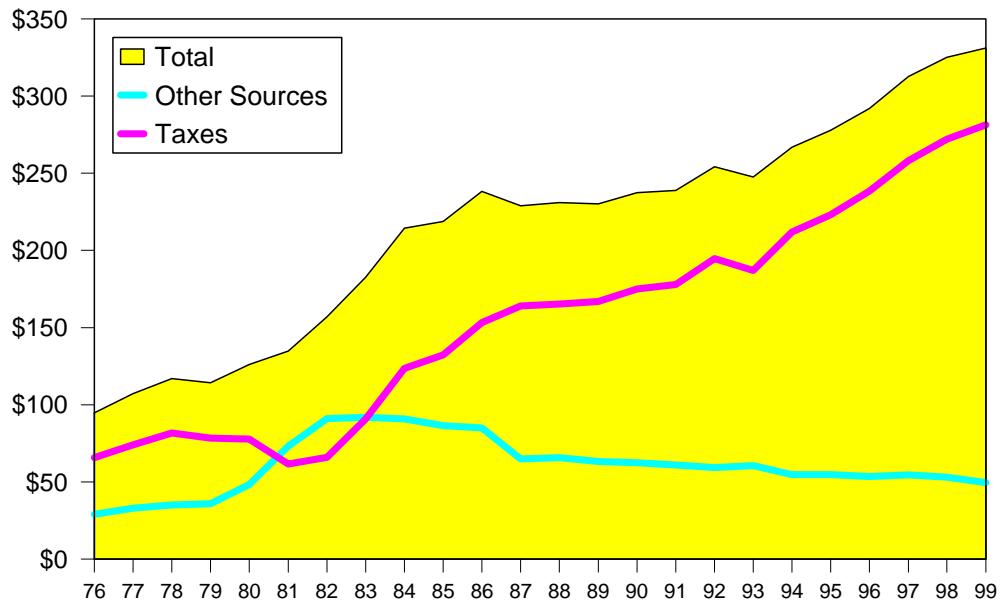

Anchorage (In Millions of \$) - 1976-1999

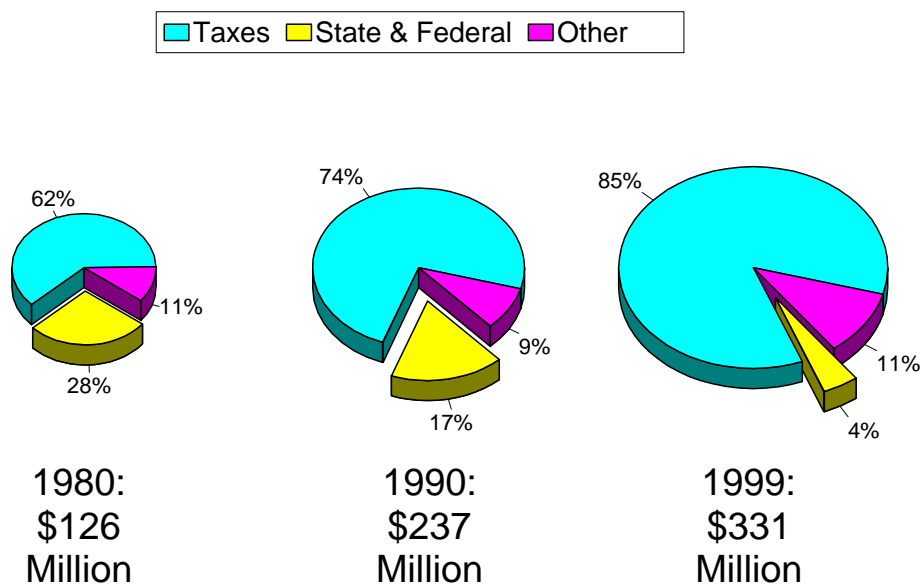
