

Muni Planning News 2025-11-10



- **McDowell Sanctuary Rezone:** The Assembly voted to approve a rezoning of the Helen Louise McDowell Sanctuary to Parks and Recreation (PR) Zoning with AO 2025-111. This was one of the first uses of the MOA's new Muni-led rezones tool, which is also in use for the Parks Rezone below.

and [PZC Case 2025-146](#) will rezone a number of parcels to parks and recreation (PR) zoning. This implements action 8-4 of the [2040 Land Use Plan](#): “*Conduct housekeeping rezone of dedicated parks to PR district, and some T-zoned lands to PLI.*” This item is currently scheduled for the December 8, 2025 Planning & Zoning Commission meeting. - **Short Term Rental (STR) regulation ordinance postponed** to the November 18 Assembly Meeting: [AO 2025-115](#).
- **Ongoing: 10 year Targeted Comprehensive Plan Update.** The Department continues to work on the [10 Year Targeted Comprehensive Plan Update](#) [focusing on housing](#) and encourages any comments or feedback.
- **AMATS Outreach:** On October 27th, The Federation of Community Councils Local Lens series [featured AMATS](#) for a presentation about what they do, how their processes work, and how to get involved. Also check out the new [90-second explainer video](#) for a snapshot of AMATS' mission, programs, and how to get involved.
- **Transit Supportive Development Overlay (TSDO):** The Planning and Zoning Commission recommended at their [October 6, 2025 meeting](#) to move the TSDO overlay ([PZC Case 2025-0030](#)) and comp plan updates ([PZC Case 2025-0034](#)) forward with additional changes and process. Per [direction from the Mayor's office](#), these cases will be on pause until further notice to allow for additional outreach.
