Staff reported on the roof truss failures in 2023 and 2024 and the letters the department sent out to building owners and tenants. The Board asked about staffing and the next code cycle. Staff stated we have three structural, one architectural, one electrical and one plumbing/mechanical plan reviewers. Mr. Noffsinger informed the board he would be retiring at the end of April.

The next code cycle will include the 2024 IBC, IRC, IEBC, IFC, IECC, IMC, IFGC, UPC and 2023 NEC. The next code cycle may also include the 2024 International Property Maintenance Code. There would be roughly ten people on each committee and a board member would chair the committee. The board stated they prefer to form the committees in the fall in order to go through the review process during the fall/winter slow time of year.

Staff mentioned the letter from the Geotechnical Advisory Committee. Mr. Arnold said he would attend a meeting or two as the Board's liaison.
