# 4. OTHER BUSINESS/INFORMATIONAL

#### a. 15.55 rewrite – legal review

Staffed gave a brief overview of the rewrite process and then sent it to legal. Legal provided 29 comments, during staff's review of the comments we found many of them were clerical changes. There were a few we are bringing to the board for discussion:

## • 15.55.031 Powers and Duties if the Director

It was decided to leave this section in the code. MOA legal staff desire that we make it clearer the director is the one who can approve modifications.

## • 15.55.055, Certificate of On-Site Systems Approval

We made some changes to this section to clarify the water quality testing and when a flow test is required

#### • 15.55.080 Well driller and pump installer certification

Legal was concerned that penalties were light for offences. We edited the language so that the department can determine when an offense is made, and it doesn't require legal action to determine.

## • 15.55.090 Subdivision Submittal Requirements

The department has developed Aquifer Testing Guidelines to be used to determine water quantity information for a new subdivision. The committee desires to be able to reference an ASTM standard instead. The Department will reach out to the hydrogeologists who helped develop the testing guidelines to see what their thoughts are on this subject. The hydrogeologists are both in agreement that we reference and maintain the Aquifer Testing Guidelines in our code section. They agree that the ATG is a much better testing method than the ASTM testing method.

Staff will provide a separate document with legals suggestions and our responses as it will be simpler when it goes back to legal to say this is our final version. We don't believe there will be any push back with the format.

#### a. Board comments

The board asked for an update on BioMicrobics. Staff commented on their original request they were using 1530-gallon infiltrator tanks; however, they came back with another submittal to use 1000-gallon tanks. It was explained they would have to do the full setup and full code required testing or they use the board approved with reduced testing. The 1530 tanks were put back in.

Chair Swenson said he would seek re-appointment. Staff explained he would need to go online and fill for reappointment.
