TELEPHONE UTILITY HIGHLIGHTS

The Telephone Utility is progressing along the lines set out in its five-year program at the time of its \$6,000,000 bond election last year. Its expansion plans through 1969 go beyond the former program considerably, costing an estimated 13 million dollars, to be raised out of Utility revenues and by future sale of revenue bonds. The basic project is to provide 23,000 more lines and 34,0000 more terminals, of which 12,000 lines and 16,000 terminals will be installed in 1964 and early 1965 to relieve the present shortage. This new central office equipment will be housed in two new wire center buildings. Most of the remainder of the program is related distribution and station equipment. One further innovation, however, is the projected purchase of automatic toll ticketing equipment in 1967, to permit extension of direct distance dialing to Alaska.

TELEPHONE UTILITY PROJECT DESCRIPTIONS

1. North Wire Center Building

Department requests \$500,000 for 1964. New 65' x 142' one-story building with basement to house telephone central office equipment at E Street near Fifteenth Avenue. Plans now in final stage. Planning Commission recommends approval.

2. Central Office Equipment

Department requests \$4.2 million over a six-year period. To provide 23,000 new lines, 34,000 new terminals and automatic toll ticketing equipment (1967). 16,000 of new terminals to be available by second quarter of 1965. Planning Commission recommends approval.

- 3. New Main Feeder and Distribution Cable Placement

 Department requests \$2.95 million over a six-year period. Numerous local projects required to increase service as scheduled and keep pace with area growth. Planning Commission recommends approval.
- 4. Routine Main Feeder and Distribution Cable Placement

 Department requests \$2,000,000 for 1964-65. Routine small projects required to increase service as scheduled. Planning Commission recommends approval.
- 5. Station Equipment

Department requests \$2.95 million as follows: \$850,000 per year for 1964-65; \$300,000 per year for 1966-69. To purchase telephones, switchboards and associated equipment.

6. South Wire Center Building

Department requests \$60,000 for 1965. New 3600 sq. ft. one-story building to house telephone central office equipment, located on Lake Otis Road near Sand Lake Road. Planning Commission recommends approval.

7. North Wire Center Building Addition

Department requests \$275,000 for 1968. New 10,000 sq. ft. addition to North Wire Center Building to meet anticipated central office expansion need at that time. Planning Commission recommends approval.
