**Description**

This project will replace approximately 8,000 sqft of carpet within the senior center that with regular wear and tear has become a tripping hazard for seniors. The project includes renovation of the bathrooms to bring them to Americans with Disabilities Act (ADA) compliant. Includes compliance for commode height, railings, sink and door accessibility and flooring. The roof has reached its useful life and deterioration of the structure contributes to frequent roof leaks requiring repairs and patches. The aging roof and garage facility will be addressed during this project.

Facility renovations to include:

A continuation of a 2018 project that will cover 8,000 square feet in addition to the 16,000 square feet floor covering under the original project. #5 - Department priority with estimated cost \$127,000.

Bathrooms renovated in compliance with Americans with Disabilities Act (ADA). #7 - Department priority with estimated cost \$95,000.

Aging roof repair. #9 - Department priority. Estimated cost \$800,000.

New garage facility to replace aging facility. #11 - Department priority with estimated cost \$1,200,000.

**Description**

The Municipality is seeking funding for the Furniture, Fixtures, and Equipment (FF&E) associated with the replacement of the 9th and L Street headquarters for the municipal Health & Human Services department (DHHS).

**Comments**

#1 - Department priority. Estimated cost \$2,265,000. The Municipality is actively taking steps to relocate the Department of Health and Human Services. The current timing and schedule of the relocation and development process recommends a request for bond funds in 2020. The existing facility was first built in 1960 as a three-story hospital and subsequently expanded to five floors. Currently, the facility houses the DHHS of the MOA, serving residents of Anchorage as a major health care clinic. The new building proposal involves redevelopment of the current DHHS location as well as development in the Tudor area. FF&E is not included in the cost of the DHHS facility replacement and must be funded separately.

Replacement of the facility is necessary because 1) the structure and its major systems have passed their useful life expectancy, resulting in high maintenance costs, 2) the configuration of the facility was not designed for its current use, resulting in inefficient use of space, and 3) non-friable asbestos exists throughout the building, creating a potential health hazard. FF&E is a critical for operations in the new facility.
