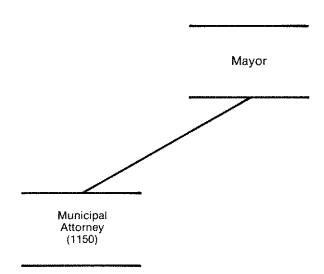

Mission

To provide legal services to all phases of municipal government operations; defend against liabilities; and provide justice and prosecution service for certain misdemeanor criminal offenses with special emphasis on drunk driving.

Major Program Highlights

- Continue to monitor the newly and rapidly developing area of municipal anti-trust liability and prepare additional anti-trust compliance plans for client departments.
- Administer and expand the Pre-trial Diversion System and the Community Work Service Sentencing referral office.
- Implement and coordinate with the Police department new enforcement techniques for drunk driving control.
- Address the increasing number of construction claims arising from the increased capital construction activity experienced by the Municipality in recent years.
