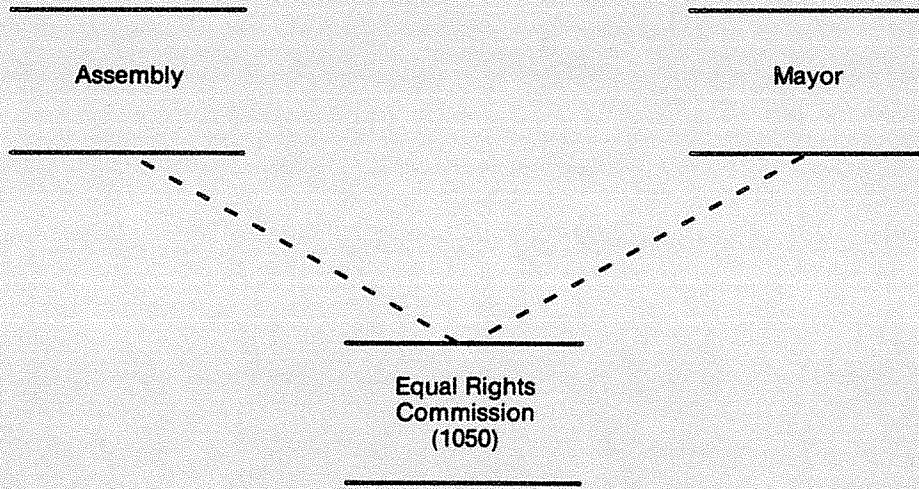

## Mission

To effectively enforce Title 5 (Equal Rights) of the Anchorage Municipal Code and to develop programs designed to prevent and eliminate illegal discrimination within the boundaries of the Municipality of Anchorage.

## Major Program Highlights

- Investigate, analyze and resolve approximately 180 discrimination complaints.
- Sponsor 100 training programs with emphasis on educational and community-wide prevention and awareness of illegal discrimination.
- Provide support services throughout the year to the Equal Rights Commissioners.
- Ensure continuation of the community-wide special programs to promote understanding and awareness of current civil rights issues.

**PROGRAM CATEGORY:**

**PURPOSE:** To enforce the civil rights of the municipality prohibiting discrimination in employment, housing, public accommodations, education, financial practices and unlawful practices by the Municipality of Anchorage.

**1985 PERFORMANCE:**

- Provide management of agency operations, staff supervision, contract monitoring and program planning and analysis.
- Complete over 100 investigations.
- Accept over 160 discrimination complaints.
- Conduct 12 regular commission meetings and coordinate 72 commission committee meetings.

**1986 OBJECTIVES:**

- Provide executive management of investigative, administrative and commission actions.
- Complete intake screening, complaint preparation, investigations and hearings.
- Investigate complaints in a timely manner.
- Represent the agency in judicial proceedings.
- Complete legal secretary tasks, recordkeeping, contract monitoring and program planning and analysis.
- Support for commission activities.

**PROGRAM CATEGORY:**

**PURPOSE:** To prevent and eliminate discrimination as required by Municipal law through improved education and awareness.

### 1985 PERFORMANCE:

- Provide education and training programs specifically developed for employers of both profit or non-profit organizations to assist them in implementing fair employment practices and adhering to municipal civil rights laws.
- Present community-wide special programs dealing with topics such as recruitment, promotion, sexual harassment, discipline and discharge.
- Expand awareness of programs available to the community through the Anchorage Equal Rights Commission.

### 1986 OBJECTIVES:

- Provide mandated training as specified in complaint closure documents.
- Provide community-wide prevention and awareness training.
- Explore alternative revenue/funding sources to enhance existing programs and expand the agency's training resources.
