

Mission

The purpose of the Anchorage Equal Rights Commission (AERC) is to prevent and eliminate discrimination within the geographic boundaries of the Municipality of Anchorage. Title V of the Anchorage Municipal Code provides protection from discrimination as to race, color, sex, religion, national origin, marital status, age, or physical and mental disability and it covers the areas of employment, housing, public accommodations, educational and financial institutions and programs and services provided by the Municipality of Anchorage.

Major Department Highlights

- Respond to 750 inquiries of discrimination within the geographic boundaries of Anchorage.
 File and investigate 60 cases of alleged discrimination in Anchorage.
- Mediate and issue 20 pre-determination settlements prior to case finding.
- Conduct 12 workshops regarding diversity, sexual harassment, and ADA awareness for the general public.
- Conduct and organize quarterly meetings for the AERC Commission. The AERC
 Commissioners review cases going to public hearing, organize AERC community outreach and
 education activities, conduct and organize standing committee activities and conduct an annual
 evaluation of executive director.
- Provide technical and administrative support for the Minority Community Police Relations Task
 Force and the Municipal Fair Housing Alliance.
- Produce 2000 annual report (on line and printed copy).

#### PURPOSE:

To eliminate and prevent illegal discrimination within the Municipality of Anchorage. Anchorage Equal Rights Commission enforces Title 5 of the Anchorage Municipal Code which provides protection from discrimination as to race, sex, religion, national origin, age, marital status, and disability.

#### 2000 PERFORMANCES:

- Responded to 750 inquiries of discrimination within the geographic boundaries of Anchorage.
- Filed and investigated 90 cases of illegal discrimination.
- Mediated & issued 25 pre-determination settlements prior to case finding.
- Conducted 50 programs for the community on the Anchorage Equal Rights Commission's (AERC) services.
- Conducted and organized quarterly meetings of the AERC Commission. The Commission reviewed cases going to public hearing, developed annual evaluation of executive director and staff attorney, conducted and organized standing committee functions.

#### 2001 PERFORMANCE OBJECTIVES:

- Respond to 750 inquiries of discrimination within the geographic boundaries of Anchorage.
- File & investigate 60 cases of allegated discrimination in Anchorage.
- Mediate and issue 20 pre-determination settlements prior to case finding
- Conduct 12 trainings regarding diversity, sexual harrassment, ADA awareness for the general public.
- Conduct & organize quarterly meetings of the AERC Commission. The AERC Commissioners review cases going to public hearing, develop annual evaluation of the executive director and staff attorney, and conduct and organize standing committee activities
- Schedule and conduct public hearings (depending on Assembly funding).


