Department Services

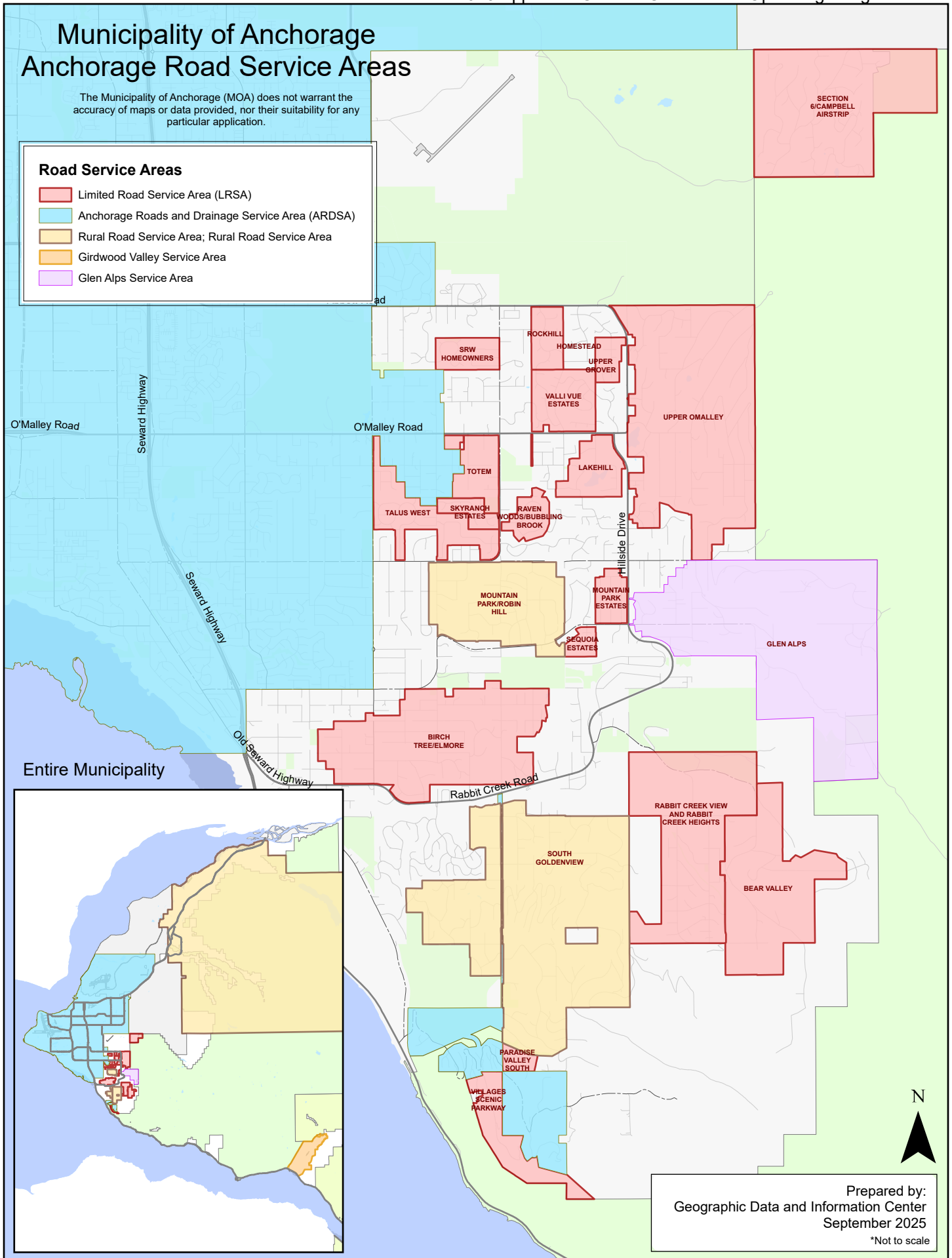
