AS 12.15.065 Residential real property tax penalty waiver

To qualify for real property tax late payment penalty waiver, property must be the applicant's primary residence (domicile) and permanent place of abode for at least 185 days prior to January 1 of the current year, have had timely payment history for the preceding 5 calendar years and meet the definition of catastrophic occurrence and align with all other definitions and requirements cited in AO No. 2017-106.
