4. Persons to be Heard:

Public Comment on proposed changes to Title 17

David Evans' Public Comment was given as follows:

- Objected to provisions that say Activities not allowed by control by command including, hiking, walking, biking, and skiing.
- If activities are going to be listed, they should include all other activities such as running, jogging, horseback riding, snowshoeing, skateboarding, riding scooters, or other segway-like devices.
- Replace "Activities not allowed by control by command" with "Control by leash is required on all of following whether or not covered by snow".
- Believes biking on a narrow trail with a long leash is dangerous and virtually impossible.

Holly Hill's Public Comment was given as follows:

• Understands now the clarification with hiking, biking, and skiing with e- collars is currently legal or going to be legal.

- Sited research showing e-collars would be a poor misdirection of the ACAB to regulate trail use.
- · Believes in force-free dog training

Michelle Sinnott's Public Comment was given as follows:

- Testifying in opposition to the proposed changes of Title 17.
- Electronic collar is a negative reinforcement training device and is not a method of control.
- Leash provision in Title 17 does not and should not dictate what training methods are appropriate for purposes of teaching recall.
- Proposal created 2 conflicting definitions for the same term.
- Control by command is not a substitute for a physical leash.

Travis Smith's Public Comment was given as follows:

Disagrees that biking hiking and skiing should be disallowed with voice control.

Frank Lahr's Public comment was given as follows:

 Control by command is about perception. What may seem like control to one may seem out of control to another.

Elise O'Loughlin's Public Comment was given as follows:

- Here to represent the equine world.
- Livestock is trained and exercised in public use areas.
- In the most recent revision, it was changed to the animals.
- Not everyone has an off-leash animal which is a dog.
- Would like to see clarification regarding the animal's definition.

Gina Ashman's Public Comment was given as follows:

- Questioned how certain activities can be completed while having the dog restrained
- E collar is not an equivalent of a leash or a training method.
- Prefer an area or trail restrictions approach.

Ray Dinger's Public Comment was given as follows:

- Representing Alaska Search and Rescue dogs (ASAR)
- Majority of dogs are trained in town
- Concerned with some language and statements.
- ASAR does try to avoid large public areas.
- Advocates for exceptions for training search and rescue dogs.

Heather Bell's Public Comment was given as follows:

Works with the search and rescue community.

- Dispatched through and affiliated with State Troopers
- Suggests that not only elaborated on control methods but the product of animal that is under control.
- A concept of passing a test and proof of ability to do so and have the privilege updated like a regular drives license.

Lillian Smith's Public Comment was given as follows:

- Believes most people have comment sense to leash the dog when appropriate and let her off as appropriate.
- This impacts someone's life with a blanket statement to say voice command is never ok when it really is up to people's judgment.
- Public needs a level of trust in each other.

Kendra Higgins' Public Comment was given as follows.

- Would like the law that is going to be implemented should be evidence-based.
- What would it look like to have this leash law enforced?
