Call to Order

The Housing, Homeless and Neighborhood Development (HHAND) Advisory Commission meeting reached a quorum and was opened by Chair Dave Rittenberg at 4:13 PM. The meeting was staffed by the Anchorage Health Department (AHD), Human Services Division (HSD), Community Safety and Development (CSD).

- 1. Ongoing Business
 - a. **Update from the Special Assistant to the Mayor for Health and Homelessness**: Special Assistant to the Mayor Thea Agnew Bemben gave updates about funding for winter shelter surge capacity, ongoing construction and the RFP for the operator of the microunits project, a potential housing rehabilitation program, and blighted properties.
 - b. **Update from Housing and Homelessness:** Division Manager Leila Taylor reiterated some of the points that Thea Agnew Bemben spoke to.
 - c. **Update from Community Safety and Development**: Program Manager Jed Drolet gave updates about Emergency Rental Assistance and how the federal shut down should not impact his program significantly for the time being.
 - d. **Discussion about the 10,000 Homes in 10 Years initiative**: Vice Chair Parks and Commissioner Sager will work on a draft of a resolution to present at the November Commission Meeting.

- Commissioner Williams expressed a desire to know the outcomes of the Sanctioned Camping
 Task Force and the Complex Behavioral Health Task Force. Thea Agnew Bemben spoke to how
 the outcomes of both are informing the Mayor's strategies. Commissioner Williams expressed
 that it would be a good idea to let the others who served on the task forces know as well.
