Public Hearing Notice

The Heritage Land Bank is proposing to dispose of HLB Parcel 2-156 to the non-profit Alaska Natural Burial for less than fair market value for the purposes of a natural burial cemetery. This parcel is 9.6 acres in size and is zoned as Public Lands and Institutions, which allows for cemetery land use. It is currently a natural area located on the west side of Golden View Drive neighboring Moen Park to the east and Potter Marsh Watershed Park to the west and south. If passed by HLBAC and the Anchorage Assembly, the project proposes to offer affordable interment services while preserving the integrity of the parcel's existing ecological features. For more information on the project, a presentation was given to HLBAC at the January 22nd meeting, and the video recording is available on our website. Please join our upcoming February meeting for a staff report, public hearing, and commissioner discussion.
