Honorable Mayor and Members of the Assembly:

I am pleased to present Sunset Audit Report 2016-S1, Urban Design Commission, Planning Department, for your review. A brief summary of the report is presented below.

In accordance with Assembly Ordinance Number 2011-64(S-1), Section 14, we have performed a sunset audit of the Urban Design Commission. The objective of this audit was to provide information to the Mayor and Assembly to assist them in determining if the Urban Design Commission should be reauthorized. Our audit included a review of meeting minutes, resolutions and agendas, and member authorization and participation.

Based on our review of meeting minutes, resolutions, and attendance records, we recommend that the Urban Design Commission be reauthorized. Our sunset audit revealed that revised Anchorage Municipal Code (AMC) Title 21, Land Use Planning, effective January 1, 2014, does not contain language regarding the Commission's composition or the number of members, which was inadvertently omitted. Staff in the Office of Economic and Community Development are currently working on revising Title 21 to include language regarding the Commission's composition and number of members.

The Urban Design Commission will sunset on October 14, 2016, unless reauthorized by the Assembly.

Sunset Audit Report 2016-S1 Urban Design Commission Planning Department

<u>Introduction</u>. We have performed a sunset audit of the Urban Design Commission (Commission) as required by Assembly Ordinance Number 2011-64(S-1), Section 14 which states:

"The Municipal Clerk shall notify the Assembly and the Mayor by assembly memorandum at least 120 days prior to the sunset of any board or commission, and an ordinance for reauthorization shall be introduced through the Assembly Chair with the assembly memorandum. The assembly memorandum shall include direction to the Office of Internal Audit to audit the board or commission under Anchorage Municipal Code section 3.20.110 D.3. and 4. The Office of Internal Audit shall report its findings to the Mayor and Assembly at least 60 days, prior to sunset, prior to vote by the Assembly on reauthorization."

Objective and Scope. The objective of this audit was to provide information to the Mayor and Assembly to assist them in determining if the Commission should be reauthorized. Our audit included a review of meeting minutes, Commission resolutions and agendas, and Commission member authorization and participation.

The audit was conducted in accordance with generally accepted government auditing standards, except for the requirement of an external quality control review, and accordingly, included tests of accounting records and such other auditing procedures as we considered necessary in the circumstances. The audit was performed during the period of June through July 2016.

Overall Evaluation. Based on our review of meeting minutes, resolutions, and attendance records,

we recommend that the Urban Design Commission be reauthorized. Our sunset audit revealed that

revised Anchorage Municipal Code (AMC) Title 21, Land Use Planning, effective January 1, 2014,

does not contain language regarding the Commission's composition or the number of members,

which was inadvertently omitted. Staff in the Office of Economic and Community Development are

3. The purpose and goal of the Commission.

AMC 4.40.125.A, Urban design commission, states "There is established an urban design

commission to exercise the powers and duties more particularly set forth in Title 21."

AMC 21.02.040, Urban design commission, states:

"A. Decision-making authority. The urban design commission has decision-making

authority over the following:

1. Appeals of administrative site plan reviews (21.03.180 C.);

 - b. The use-specific standards of chapter 21.05, Use Regulations (except subsection 21.05.040K., Telecommunication Facilities), section 21.09.050, Use Regulations, and section 21.10.050, Use Regulations;
 - c. Chapter 21.07, Development and Design Standards (except subsections 21.07.020C., Steep Slope Development, 21.07.050, Utility Distribution Facilities, and 21.07.060, Transportation and Connectivity);
 - d. Those provisions of section 21.09.070, Site Development and Design Standards, for which variance authority is not given to the platting authority or the zoning board of examiners and appeals;
 - e. Section 21.09.080, Building Design Standards;
 - f. Section 21.10.070, Development and Design Standards (except subsection 21.10.070B., Transportation and Connectivity); and
 - g. Chapter 21.11, Signs; and
- 7. Appeals of the director's decision regarding subsection 21.12.060B., Bringing Characteristics Into Compliance (21.03.050).

- B. Other powers and duties. The urban design commission shall:
 - 1. Advise the mayor, assembly, and planning and zoning commission regarding urban design, northern climate design, and winter city design matters, including design-related amendments to the comprehensive plan and Title 21.
 - 2. Review and make recommendations regarding any entitlement requests, in accordance with authority delegated by the planning and zoning commission or platting board under this title.
 - 3. Perform those duties stated in Title 7, relating to the art funding requirements for public buildings and facilities.
 - 4. Designate historic signs pursuant to subsection 21.12.070 F.
 - 5. Exercise such other powers, and perform such other duties, as are provided by law."

4. Have Commission members been appointed?

Revised AMC Title 21, *Land Use Planning*, effective January 1, 2014, does not contain language regarding the Commission's composition or the appointment of Commission members, which was inadvertently omitted. Staff in the Office of Economic and Community Development are currently working on revising Title 21 to include language regarding the Commission's composition and number of members.

<u>Audit Finding</u>. Although Title 21 does not refer to the Commission's composition or the number of members, Commission members were still appointed. Historically, this Commission had nine members.

5. Are the terms of the Commission members current?

AMC 4.05.040, Terms, states "Except as otherwise specified in this Code, the regular term of each member of a board or commission is three years commencing on October 15 of the year in which appointed and ending three years thereafter on October 14, provided however, to avoid a vacancy until new appointments can be made and confirmed, an appointed member's term is extended until a new appointment is confirmed or a maximum of 120 days which ever occurs first. The terms of initial or subsequent appointments to a board or commission shall be staggered so that, as nearly as possible, a pro rata number of its members shall be appointed each year of the established regular term of office."

<u>Audit Finding</u>. Although AMC does not contain language regarding the Commission's composition or the number of members, the terms for the eight Commission members were current.

6. Are positions deemed vacant after the maximum number of absences?

AMC 4.05.060.A, Attendance requirements; vacancies, states "...a vacancy shall occur if a member during any 12-month period while in office:

- 1. Is absent from three regular meetings without excuse;
- 2. Is absent from:
 - a. six regular meetings; or
 - b. eight regular meetings for members of the planning and zoning commission, platting board, or zoning board of examiners and appeals; or
- 3. Fails to attend a two-thirds majority of the regular meetings."

<u>Audit Finding.</u> No members were absent from three regular meetings without an excuse within any 12-month period.

No members were absent from six regular meetings within any 12-month period.

All members attended at least two thirds of the regular meetings within any 12-month period.

7. Does the Commission meet regularly?

AMC 4.05.090, Meetings, states "A board or commission shall hold regular monthly meetings at such time and place as may from time to time be designated by the board or commission, but meetings need not be held if no business is pending. Boards and commissions shall advise the public of their meeting schedules, or publicly advertise their meetings where necessitated by statutory requirements. The chairman of a board or commission, or the municipal employee who is designated as an ex officio member of the board or commission pursuant to section 4.05.140, or a majority of the board or commission, may call a special meeting of the board or commission. Meetings of all boards and commissions shall be open to the public, except for an executive session, from which the public may be excluded."

<u>Audit Finding</u>. From January 2015 through June 2016, the Commission met 18 times. Meetings are publicly announced on the Boards and Commissions Events' website and the Municipality's Public Notices website.

8. Are minutes taken and published?

AMC 4.05.130, Reports, minutes and public hearing records, states "A board or commission shall keep minutes of the board or commission proceedings, and such minutes shall record the vote of each member physically present upon every question formally presented to the board or commissions for its consideration. The minutes shall be maintained in the custody of the municipal agency which supplies staff support to the board or commission and shall be a public record, open to inspection by any person."

<u>Audit Finding.</u> Minutes were taken at each Commission meeting. These minutes and audio recordings are posted on the Municipal Meetings' web page. In addition, Planning Department staff keep a copy available for the public.

9. Do meetings have action items or other business?

AMC 4.40.125.A states "There is established an urban design commission to exercise the powers and duties more particularly set forth in Title 21."

AMC 21.02.040 states:

- "A. Decision-making authority. The urban design commission has decision-making authority over the following:
 - 1. Appeals of administrative site plan reviews (21.03.180 C.);
 - 2. Major site plan reviews for non-residential development with a gross floor area of less than 100,000 square feet, and for residential development of fewer than 140 units (21.03.180 D.);
 - 3. Preliminary plats, when a major site plan review under the authority of the urban

- design commission creates a subdivision or requires the vacation of a dedicated public area, and the commission directs in the major site plan approval that it shall act as the platting authority (21.03.180 F.);
- 4. Plans in hand design drawings review for new construction and reconstruction of streets of collector classification or greater on the Official Streets and Highways Plan (21.03.190);

 - g. Chapter 21.11, Signs; and
- 7. Appeals of the director's decision regarding subsection 21.12.060B., Bringing Characteristics Into Compliance (21.03.050).
- B. Other powers and duties. The urban design commission shall:
 - 1. Advise the mayor, assembly, and planning and zoning commission regarding urban design, northern climate design, and winter city design matters, including design-related amendments to the comprehensive plan and Title 21.

- 2. Review and make recommendations regarding any entitlement requests, in accordance with authority delegated by the planning and zoning commission or platting board under this title.
- 3. Perform those duties stated in Title 7, relating to the art funding requirements for public buildings and facilities.
- 4. Designate historic signs pursuant to subsection 21.12.070 F.
- 5. Exercise such other powers, and perform such other duties, as are provided by law."

<u>Audit Finding.</u> From January 2015 through June 2016, the Commission issued 25 resolutions.
