Jennifer, Kellie, and Kyle,

I'm wrapping up final tasks in my last few days in the office and wanted to circle back on a few things I had noted as outstanding requests from the GBOS team from our last quarterly meeting. Apologies for the delay in getting back to you on these items.

First, I had a note that you had asked **why municipal assessed value does not appear to track with the increase and decrease in the market value of a home and, as a corollary, why so many homes in Girdwood experienced changes in assessed value this year.**

Jack, our Municipal Assessor, helped me with the following response:

- For 2026, Property Appraisal updated parts of the residential assessment model to better reflect current market information and align better with national assessment standards. The basic approach to valuing homes did not change, but some of the information used in the model was updated, including construction cost data, home quality categories, and the way homes are grouped into market areas. In Girdwood, those updates were combined with a larger local market adjustment than most residential areas received. Put simply, recent market data showed that Girdwood assessments had not kept pace with the market, so the 2026 Girdwood values included both the general model updates and an additional market correction.

Jack is cc'd here, so that you might follow up with him directly with any follow up questions.

Additionally, I had a note that you had asked about **why a traffic study has not been completed by the Municipality as part of the Holtan Hills development, and whether such a study might still be a possibility.**

Tiffany from Real Estate and Greg Soule from Development Services helped me with info informing the following response:

As I know you all know, the Municipal Traffic Department does not directly complete traffic studies related to specific private developments (it is not adequately resourced to do so). A traffic study requirement is imposed on a developer as a condition of approval on the platting action for the new development. With respect to Holtan Hills, the plat application for phase 1 of the project has been submitted and the Traffic Department has determined that the trip generation for phase 1 does not hit the minimum threshold for imposing the traffic study requirement. That said, this may change as platting actions for additional phases of the project come forward.

Again, Tiffany and Greg are cc'd for any follow up questions.

I've also cc'ing Bill Falsey for further follow up, as he will be stepping back into the Municipal Manager's shoes after my departure. It has pleasure working productively with you all on Girdwood issues.

ANCHORAGE WATER AND WASTEWATER UTILITY

GIRDWOOD DRINKING WATER WELLS



In 2025, the Anchorage Water & Wastewater Utility (AWWU) decided to explore options for a new primary water supply source for Girdwood to ensure that any major infrastructure investment will best meet the community's future water needs. Based on continuing water master planning efforts and AWWU's understanding of anticipated development in Girdwood, it became clear that an additional water source would be required in Girdwood in the near future.

AWWU has completed a detailed evaluation of potential sites for developing a new water source in Girdwood. The analysis considered a complex array of factors, including site accessibility, available well information and understanding of hydrogeologic conditions in the area, proximity to existing water and sanitary sewer infrastructure, land use considerations (zoning and land use designations), regulatory considerations for treatment (surface vs groundwater, emerging contaminants), hydraulic operations and criteria, production capability of the sources, floodplain status, and Water Master Planning considerations – redundancy, storage, etc.

Four sites were identified as having the best potential to meet the project criteria and goals for the development of a new water source. Those four sites were:

Alternative 1 - This alternative considered the use of AWWU's existing main water source, Well 2, and developing additional well(s) on a parcel adjacent to the existing well site near the Girdwood Airport.

Alternative 2 – New Girdwood Townsite Tract 17B - AWWU conducted preliminary groundwater and soil investigations for this potential well site.

Alternative 3 – Adjacent to the Holtan Hills development. It is unlikely a high-yield well could be developed anywhere within the Holtan Hills subdivision on the west side of Glacier Creek due to the absence of thick alluvial deposits away from the creek and the presence of shallow bedrock. In the absence of good groundwater in this area, this alternative considered the installation of a horizontal well (via horizontal directional drilling) beneath Glacier Creek at the southern edge of the Holtan Hills subdivision.

Alternative 4 – This alternative would involve the purchase of private property in New Girdwood Townsite, where it might be possible to develop and operate a high-yielding well that may not need to be treated according to surface water rules, thereby decreasing treatment costs and complexity.

AWWU leadership, engineers, and water treatment leads along with consultants with subject matter expertise evaluated and ranked the alternatives during an Alternative Selection and Decision-Making Workshop held on February 11, 2026. Based on the recommendations from the evaluation, the proposed project for an additional water source in Girdwood includes:

- A new, high production water well (Well 3). It is anticipated that the new well would be located to the northeast of the existing well site.
- A new, backup well that would replace Well 2.
- A direct filtration and UV disinfection system. Backwash water from the filtration system would be routed to the existing sanitary sewer system.
- A new approximately 40-foot by 70-foot water treatment plant (WTP) building to accommodate the new treatment system and associated piping and appurtenances. It is anticipated that the

new building will be constructed adjacent to the existing building to keep the existing system online until the new building is ready for service. An approximate 2-acre property acquisition would be required for developing the new treatment plant. It is anticipated that an Intergovernmental Agreement within the Municipality of Anchorage (MOA) for AWWU to use Heritage Land Bank (HLB) land to the north (Parcel #07531109000, part of Holtan Hills Tr 4) would be sought for the new well site and water treatment plant.

- For disinfection purposes, a new on-site hypochlorite generation system, new chemical feed systems (coagulant & hypochlorite systems), and associated piping and appurtenances.
- Decommissioning wells Obs. 87-1, 87-2, 87-3 (near the existing wells) per the Alaska Best Management Practices For Maintaining or Decommissioning Water Wells and Boreholes subsections 6.2.D.2.a.i and 6.2.F. Also, decommissioning the test well on Lot 17b in New Girdwood Townsite (NGT).

The total estimated construction cost for the selected alternative (Alternative 1) in 2026 dollars is approximately \$20,500,000, with an estimated annual operation and maintenance (O&M) cost of approximately \$1,730,000.

AWWU is moving into the design of Alternative 1, and anticipates the following schedule for the design and construction of a new water source in Girdwood:

The project team anticipates providing a project update and presentation to the Girdwood Board of Supervisors (GBOS) in early 2027. The presentation will provide an overview of the project design, discussing key design elements and project milestones.

AWWU appreciates the community's interest and participation as the project advances through design.

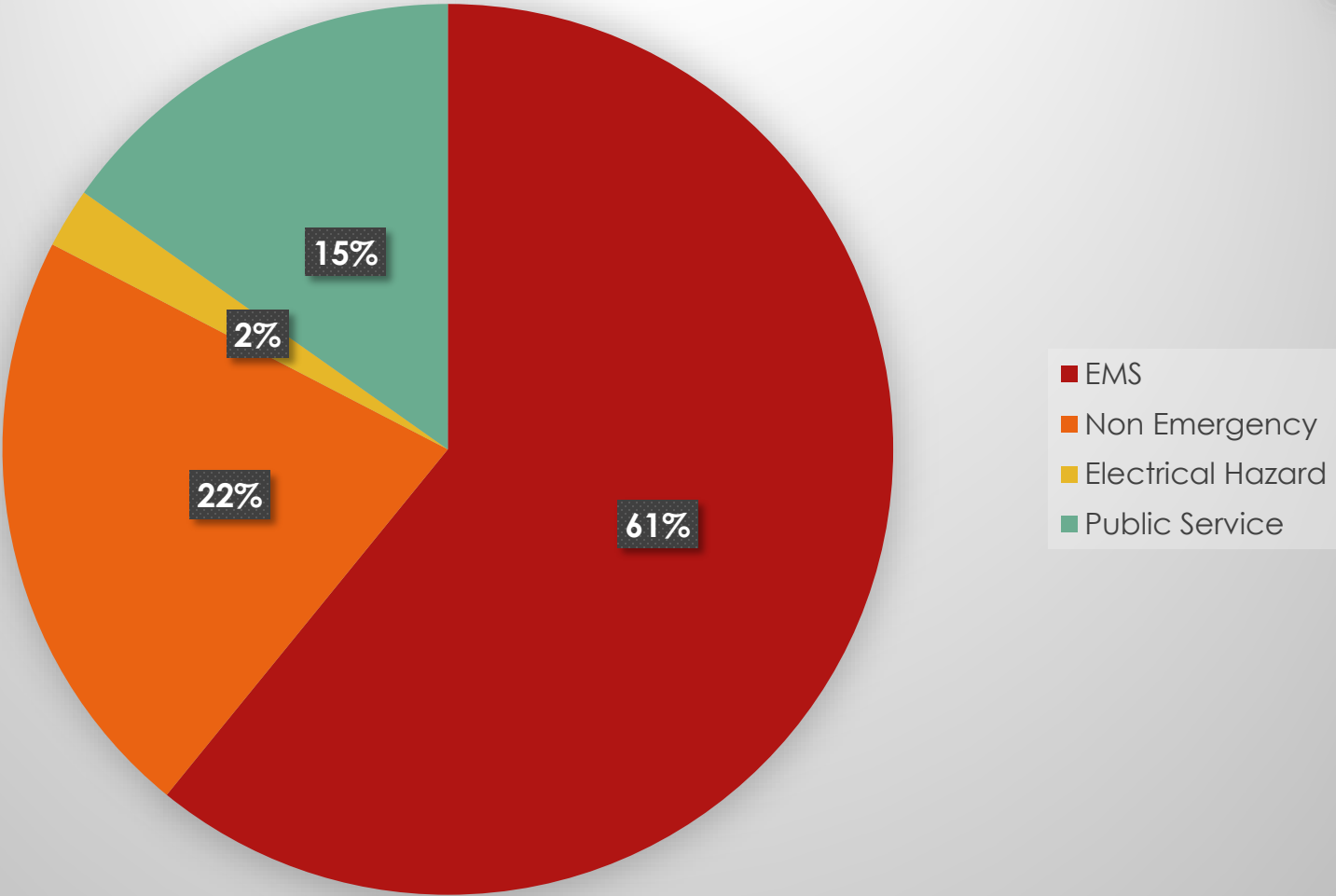

Special Activity Report - Fourth of July Weekend

Reporting Period: July 3-5, 2026

Executive Summary

During the July 4th weekend reporting period, WPD documented 79 total calls for service from July 3 through July 5, 2026. Activity was concentrated in Girdwood with 59 calls (75%), followed by Whittier with 17 calls (22%) and Other areas with 3 calls (4%). Security checks accounted for 29 calls and are included in the total call count; excluding security checks, officers handled 50 operational calls.

Key Points

- Total calls: 79 over the three-day holiday weekend.
- Operational calls excluding security checks: 50.
- Traffic-related activity was the largest operational category with 17 calls, including traffic stops, traffic enforcement, REDDI/reckless driving, traffic complaints, and traffic hazards.
- Proactive activity remained high with 29 security checks and 5 foot patrols.
- Notable calls included 2 hit-and-run reports, 3 medical calls, 1 fireworks complaint, 1 welfare check, 1 trespassing call, 1 missing person call, and 1 physical fight.
- No death-related call type was identified in the provided data.

Narrative Summary

The July 4th weekend produced a mix of holiday-related public safety activity, proactive patrols, traffic enforcement, and routine calls for service. Girdwood accounted for the majority of documented activity, with a substantial number of security checks, foot patrols, traffic calls, parking problems, noise complaints, and two hit-and-run related calls. Whittier activity included public assists, medical calls, traffic enforcement, a fireworks complaint, a welfare check, trespassing, a missing person call, and other service-related responses.

Traffic-related calls were the leading operational category. The dataset included traffic stops, traffic enforcement, reckless driving complaints, a REDDI report, a traffic hazard, and a traffic complaint. This indicates a significant enforcement and roadway-safety component during the holiday weekend.

Security checks were a major portion of the call volume and appear to reflect proactive area checks during the holiday period. These checks were especially concentrated in Girdwood, including Alyeska, Arlberg, Hightower, Mount Hood, Toadstool, Lindblad, Egloff, and Seward Highway-area locations. Whittier security check activity was also documented.

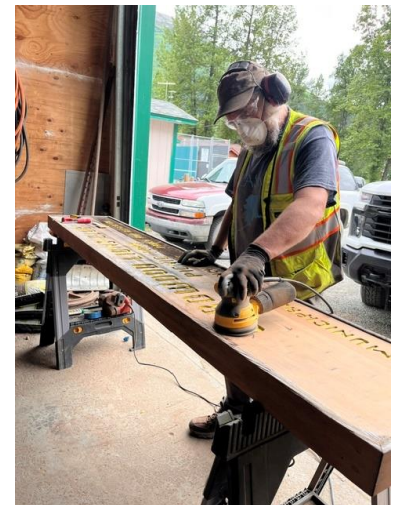

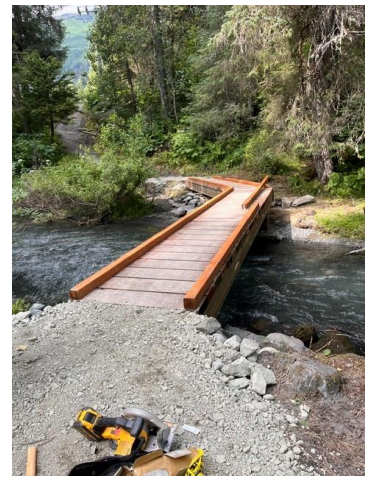
GTC mapping subcommittee is finishing up the winter map.

2027 grant cycle was announced July 1; applications available August 3 - September 11.

Other Grants:

National Forest Foundation Matching Awards Program (MAP) Grant: GVSA was not awarded this grant. Staff attended feedback session; next application round is in the summer with fall award.

Land and Water Conservation Fund (LWCF) Grant: GVSA applied and was awarded a grant for the Lions Club Park Pavilion. Match is 1:1. LWCF grant request is \$103,737.00 for a project costing \$207,474.00. Grant must be wrapped up by 2027. Kyle has completed reporting for now. Staff is working on interpretive signs; materials are ready for construction May/June 2026.

Recreational Trails Program Grant (RTP): GVSA/GTC opted not to apply for 2026 RTP grant. In 2024 GTC/GVSA was awarded RTP funding for the Middle Iditarod National Historic Trail. This project is under way and will continue through 2026. Kyle is working on reimbursements,

currently in winter shut-down, poised for start in spring. RTP moved to DOT for future grant rounds. We're watching for the next grant cycle.

Rasmuson Foundation: GVSA received \$250,000 Tier 2 Grant to assist with construction of the suspension bridge to replace the decommissioned hand tram.

National Forest Foundation: GVSA has completed application through the National Forest Foundation of approximately \$220,000 for the bridge to replace the hand tram.

Alaska Community Foundation: Trail Care Fund Grant application was not successful.

Anchorage Park Foundation: GTC was awarded grant with 1:1 match for interpretive signs for the interpretive center at the suspension bridge.

Roads and Drainages

Road Status: It has been a busy spring/early summer for road maintenance and projects. The following items have been completed:

- Spring sweeping of all paved roads collected 400 tons of debris from the roads
- Spring grading and compaction of all gravel roads has been completed. 50,000 lbs of calcium chloride have been applied to the gravel roads for dust suppression and road hardening. We have another 20,000 lbs in reserve to reapply to main connectors as needed.
- Drainage work completed on Vail, St. Johann, Alpine Meadows, Northland, Alta, Brighton, Alyeska View, Lake Tahoe, Mount Hood, Arlberg, Olympic Mountain Loop, Jewel Mine, Timberline and Crystal Mountain. The work consisted of reshaping the ditch, lowering driveway culverts, adding more road material to improve drainage, and replacing culverts. We also addressed areas that had chronic icing issues this winter.
- All paved road traffic-painted lines have been repainted. All traffic signs have been repaired and will be addressed as problems arise.
- After the Blueberry Festival, crack seal all asphalt and do asphalt patch repairs
- Plan for ditching and road surface work in Old Town on Gold Avenue and Old West in late August
- Another round of projects and maintenance of roads will happen in the late summer/early fall after we complete the rebid of the roads contract in August. In the meantime, GVSA staff will be making brushing improvements in various spots throughout the service area to open the line of sight and improve drainage access as needed.
- Currently have ITB for 1200 tons of e-chips with 6% salt for winter traction control

Major project updates:

Ruane Road fish passage culvert replacement. The Boutet company will lead project management for this new culvert project, and the Jacobs company will assist in ensuring compliance with the EPA grant and federal requirements. EPA has approved our Request for Proposal (RFP) for Design and Engineering services for the new culvert. An RFP is currently being advertised by MOA Purchasing to solicit bids from professional firms to provide the design services for the construction of the new culvert. The selection committee is currently considering the proposals. Still on pace to be constructed in summer 2027.

Winner Creek Trail Bridge at the Glacier Creek crossing: A contract has been signed with Spernak and Sons for them to procure the bridge construction materials and build the bridge. We have a pre-construction meeting with the contractor this week to kick off the project and confirm the construction schedule. This project will start this summer and be completed next summer in 2027. The materials needed for this project have long lead times, and recent disruptions in global markets have led to unforeseen increases in material, freight, and fuel costs. Besides the challenges this project already faces because of its location, these unforeseen market conditions only add more work to complete this great bridge for the community.

GVSA Road Maintenance contract: The five-year contract with Western ended in April, but we extended it by 120 days to work with Purchasing to establish a new bid that meets their updated requirements. In April, we had a meeting with Purchasing to determine how we should correctly account for summer construction work and pay Davis-Bacon wages to the contractor for the work performed. We finally worked out documents and equipment specifications that the Purchasing department will accept, so we can issue a contract for bidding. Eagle River roads are in the same position, so we've worked with them to flesh out the language that purchasing approves. All documents for bidding the new GVSA have been submitted to Public Works Administration leadership for their review. I am hoping they complete their review this week so we can get it over to MOA Purchasing to solicit bids from contractors. The goal is to complete the Invitation to Bid process so we have a new contract in place by October 1st.

John Trautner
12/04/1935-9/19/2022

John was a businessman, logger, gold miner, wildlife photographer and had loved everything about Alaska since he read Jack London's *Call of the Wild* in a one-room schoolhouse in Minnesota. He finally made it to Alaska in 1953 and moved to Girdwood in 1969. He never left.

He was involved in all aspects of life in Girdwood by working at Alyeska Resort, serving as fire chief, and being voted onto the Board of Supervisors.

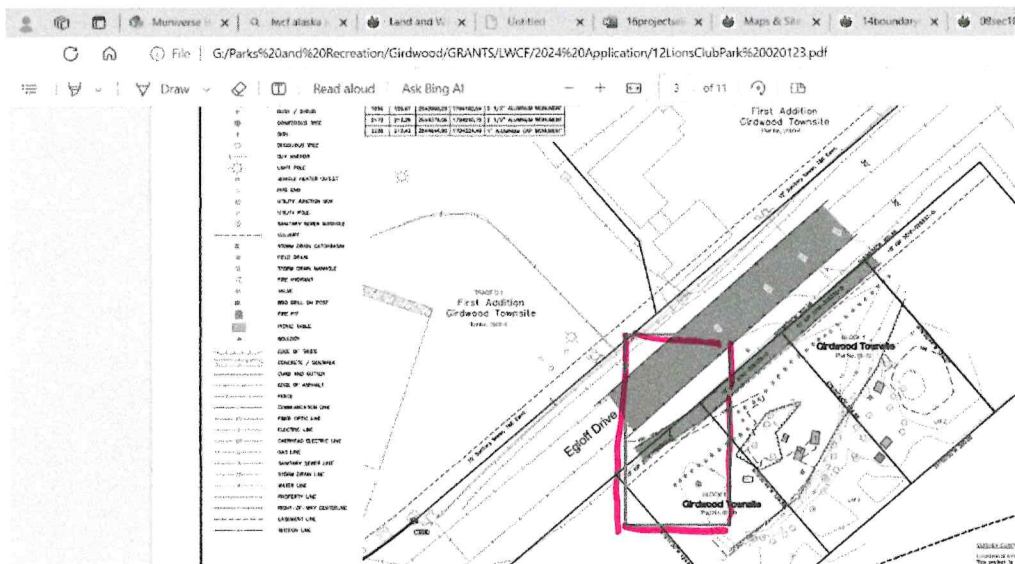
He owned the Texaco Service Station on the Alyeska Highway (1977-1995) and was a mentor and financial supporter of many young people who wanted to start or build a business in Girdwood.

He served in Lions Clubs International from 1953 until his death and helped charter the Girdwood Turnagain Arm Lions Club in 1992. Through the local Lions Club, he explored the options for building a picnic pavilion in the Girdwood Lions Park to encourage families to be outside as much as possible in spite of our rainforest weather.

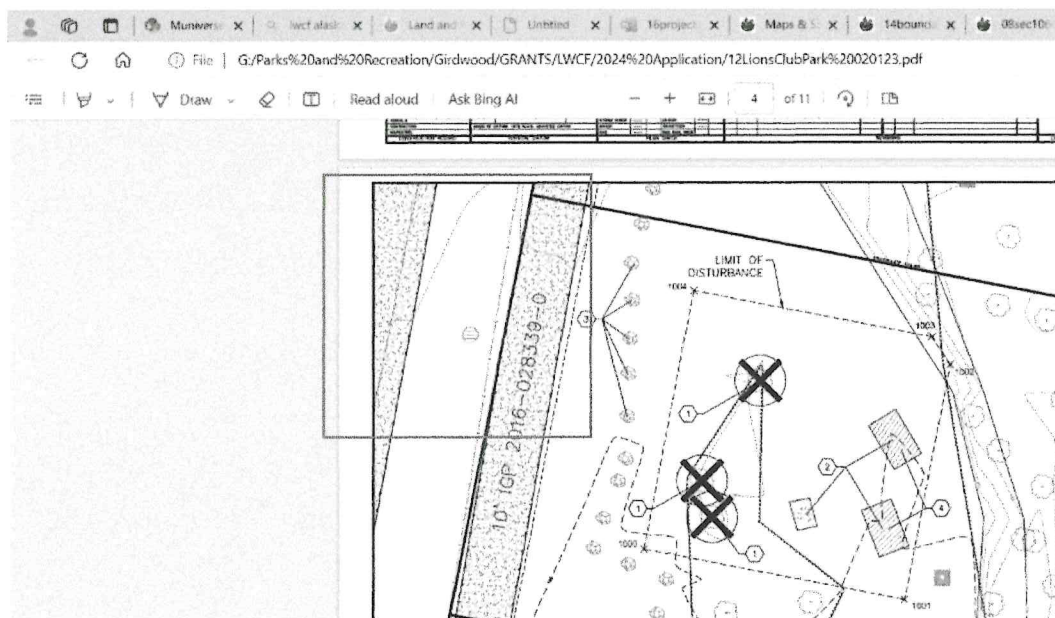
After John's death, the Girdwood Lions continued to raise considerable funds and work with Girdwood Parks and Recreation Office to plan and build a pavilion acceptable to Municipality of Anchorage codes. The pavilion was completed this June, and people use it every day.
