OLD BUSINESS:

- 6. Bed Tax allocation to Girdwood to mitigate negative impacts of STR. (Edgington). Information included in the meeting packet. Many groups and projects are looking toward these funds to support. No specific request for GBOS at this time, more information to come.
- 7. Airport Parcel H: Alaskans for Responsible Airport Development has hired attorney for assistance. Group has no request of GBOS currently and requests to stay on agenda as a standing report.
- 8. PSAC recommendation for GBOS Resolution of Support for two year extension of the Girdwood Police Services Contract (Dec 31, 2027) between the Municipality of Anchorage and City of Whittier, including an increase for Dispatch Services, at a total cost NTE \$816,905 per year (Okonek)

GBOS received memo from WPD outlining costs for contract extension for 2 more years. This will be considered as part of the full GVSA budget at the next budget work session. GBOS interested in discussing having policing for large private events subsidized by the event organizer, not the community. GBOS also is interested in learning what it would take for WPD to enforce municipal code more broadly. No action at this meeting.

9. GHEC Committee Appointment (Edgington)

10. Agenda Item LUC 2506-04 LUC and GHEC recommendation that GBOS write a Resolution of Support for HLB to subdivide the buildable tract from the parcel as a whole and designate the land for development by a Girdwood non-profit via Public Private Partnership, with a goal of 50% of the land dedicated to development of workforce/affordable housing purposes (Krystal Hoke/Edgington/Wingard)

Draft resolution is laid on the table for GBOS consideration by Krystal Hoke. See meeting packet for initial version and revisions.

- 11. Agenda Item LUC 2507-05: Request for GBOS Resolution of Support for HLB to initiate a Site Specific Land Use Study before any development is initiated in Girdwood. (formerly Agenda Item LUC 2406-04, closed 10.24) (Tuttle/Wingard) Letter requested from petitioner has not been received. Without this GBOS has no request to make of the MOA other than what was already rejected based on lack of requirement by code. Tuttle will provide a letter that outlines her argument.
- 12. GVSA Manager request GBOS approval to encumber the following funds (Kelley):
- \$160,300 from the Girdwood 406 Glacier Bridge fund for TBC professional services for the construction of the bridge This covers overall cost for bidding, construction and warranty, however if bids come in higher than available funds, the project will be suspended for fundraising. In that case, the bid package of about \$15,000 would be the only cost incurred and those documents would remain relevant for eventual construction.

 \$40,417 from the Girdwood 406 undesignated Road and Drainage fund for Jacobs support with grant for Ruane Road culvert

Ruane project is substantially funded via EPA grant which requires technical skill to access and reimburse. Jacobs is the contractor to handle this work.

GBOS moves to approve NTE \$40,417 from the Girdwood Road and Drainage 406 account for Jacobs grant management support of the Ruane culvert project.

GBOS expresses interest in project creating better public access to the creek along the shoulder of Ruane Road.

13. GVSA Manager request for NTE \$144,000 from Girdwood Parks and Rec Capital fund for construction of Lions Club Park Pavilion (Kelley)

GVSA has just received quote for construction materials and contractor for the Lions Club Park Pavilion, a project that has substantial grant funding from LWCF and supplemental funding from Girdwood Lions Club. Although construction may not occur until next year, the cost of supplies will continue to rise, request is to purchase materials now so that the project is closer to completion. Reimbursement is 50% of the costs, so GVSA will be reimbursed about \$75,000 of these funds once the project is complete.

14. GVSA 2026 Budget review and approval. Budget meeting #2 will likely be held next week. Final budget approval will be considered at the GBOS September meeting. Budget then goes to Assembly process for approval.

- 15. Girdwood Fire Department request NTE \$31,000 for equipment and hose replacement from the Fire Dept 406 account. GFR will provide updated request in the form of a resolution for consideration at the Sept GBOS meeting
- 16. Review and consider GBOS resolution regarding draft AO to allow change code to allow GBOS to propose changes to T21C9. This action will mirror the existing relationship between MOA and Chugiak/Eagle River regarding requests for code changes. This comes at the request of GBOS of the administration in MOA GBOS meetings.
- 17. Review and consider GBOS resolution regarding draft AO to increase Girdwood resident participation on the HLB Advisory Commission by one (creating two total of a board of seven). This action will increase the minimum number of Girdwood residents to participate in HLBAC. Supervisor Wingard expresses interest in having the board more representative of the location of land managed by HLB, the majority of which is in Girdwood.
- 18. PSAC recommendation for GBOS resolution of support for a traffic and traffic control measures study on Hightower Road from Alyeska Highway to Girdwood k-8 school. (PSAC/Sullivan)
 PSAC recommends being proactive with the addition of housing and therefore traffic in the town center and school proximity.
- Crystal Mountain Road No Parking Sign request (Parish/Okonek)
 Request of neighbors on Crystal Mtn Road: roadside parking creates access and safety issues during winter.
- 20. GBOS statement on the 50th Anniversary of MOA Unification September 2025 is the 50th anniversary of "Munification". Girdwood may have more to share and aspirational goals for future years. MOA has website information on the celebration. MOA50
