Assembly members – Z. Johnson: AO passed prohibiting camping in some specific locations to deter homeless camps. Assembly completed land transfer approval for Extension Trail to Girdwood Parks and Rec and for mountain bike trails to Bikewood. Grant Funds transfer to Little Bears for new facility \$200,000. Approval of funds for offsite improvements related to Holtan Hills is to be competed soon. This creates some confusion as the work has already begun.

Anchorage School Board Liaison – Andy Holleman: ASD has joined lawsuit related to federal funding of schools. Governor veto of school funding will impact ASD with larger class sizes. Override of veto unclear.

NEW BUSINESS:

- 11. GHEC Committee recruitment. GHEC member has resigned. Staff presents recruitment flyer to be posted July 22 with a goal of providing candidates for GBOS to consider at their next regular meeting.
- 12. Agenda Item LUC 2506-04 LUC recommend GBOS write a Resolution of Support for HLB to subdivide the buildable tract from the parcel as a whole and designate the land for development by a Girdwood non-profit via Public Private Partnership, with a goal of 50% of the land dedicated to development of workforce/affordable housing purposes (Krystal Hoke) LUC has already reviewed and recommended GBOS Resolution of Support. Their recommendations will be discussed at GHEC in early August. GBOS discusses the percentage of disbursement of funds and possible changes to that (currently 25% each to GVSA, General Fund, GCLT and HLB). Group also discusses creating a more ambitious goal for the amount of workforce housing created. These specifics are beyond the scope of the support for subdivision of the property, but key to gaining and maintaining support in the community.

ME and JW will work with GCLT on drafting a resolution for GBOS to review next month.

13. Agenda Item LUC 2507-05: Request for GBOS Resolution of Support for HLB to initiate a Site Specific Land Use Study before any development is initiated in Girdwood. (formerly Agenda Item LUC 2406-04, closed 10.24) (Tuttle)

in 2024 when it was pursued and determined that the Site Specific Land Use Study is not required by code. Item will be continued at LUC next month with information shared with GBOS.
