Agenda Revisions and Approval: Mar 5 2026 GBOS SM agenda approved

TOPIC:

1. GHEC 2026 Budget

GVSA manager requests that GBOS reconsider the earlier approved budget of \$40,000 for GHEC in 2026 and revise to \$100,000. An error at OMB had added the \$40,000 to the prior years' funding, so 1Q Revision discussion earlier was related to fixing that error. At that time GBOS intended to tap Undesignated Fund for amount for Housing Study, if approved. It appears that getting funds from the Undesignated Fund would be a lengthy process, and having funds to cover that study within the existing budget would be simpler. GBOS discussion on GHECs recommendation for the housing study is old business on the March 23 agenda. Impact to the mill rate will be to bring it from the current estimate of 5.34 mills to 5.43 mills.

GBOS approves 1Q Revision to put \$100,000 in the 2026 budget for Girdwood Housing and Economic.

Other updates:

Continued cold over the last 2 weeks has caused many drainages to freeze and groundwater is flowing in new locations. Steam truck has been working constantly since cold snap began. Change in weather is likely to bring a foot of snow; Western crew will need to plow. Kyle is working with purchasing to bring in the alternate steam truck, as we did in the last warm-up.

Service area has requested that MOA and Western consider extending road contract so that contract requirements can be confirmed for next contract cycle.
