1. Review of grant process (Staff and Guy Wade): Presentations are followed by individual review and evaluation by GBOS. Then a weighted average will be calculated and grantees will be required to complete a revision form to match their GBOS funding. Review Budget funding for 2024 GVSA Non-Profit Grants: Funding is \$35,000 for the 5 grantees to split. FVCS is hard-funded at \$35,000.
