DRAFT: DISTRICT 6 POSITION STATEMENT ON HOUSING & HOMELESS SHELTERS

1. COMMITMENTS

It was recommended at the August 16, 2023 meeting, that all District 6 Community Councils publicly commit to the following conditions:

- A. No District 6 Community Council shall recommend, nominate, or support the establishment of a homeless shelter or low-income public housing that is not within its own boundaries, unless it is formally supported by the Community Council whose boundaries it would be located.
 - i. Rationale: This blocks one District 6 CC (e.g., Rabbit Creek) from nominating the establishment of a homeless shelter or low-income public housing in another District 6 CC area (e.g., the Bayshore/Klatt or Old Seward/Oceanview CC areas), unless it is formally supported by that CC.
- B. District 6 Community Councils may not formally recommend, nominate, or support the establishment of a homeless shelter or low-income public housing inside its boundaries AND within 1.5 miles of any adjacent District 6 Community Council's boundaries, UNTIL it obtains the formal written consent of the adjacent Community Council's whose common boundary(s) is also within 1.5 miles of the site under consideration.

i. Rationale:

1. This condition addresses the concern that a District 6 CC might recommend, formally nominate, and support the establishment of a homeless shelter or low-income public housing within its bounds, but also within close proximity of a different District 6 CC's area, without it's formal written consent, and that such shelters may adversely impact neighborhoods outside the District 6 CC formally proposing the facility. For example, should Rabbit Creek CC want to formally nominate a site for a shelter or public housing that is located at the intersection of Sabine St. and E. 142nd Ave., then formal written consent would need be obtained from the Huffman/O'Malley CC and the Old Seward/Oceanview CC, for Rabbit Creek CC to formally nominate and establish the shelter or public

- housing because the site location is within 1.5 miles of these other CC's common boundaries.
- 2. Studies and reports show that homeless shelters and low-income public housing contribute to increased crime in neighborhoods around such lodgings. Crime linked to homeless shelters and/or low-income public housing includes: arson, assaults, property theft, burglaries, harassment, public exposure and indecency, trespassing, trash, open drug use and dirty needles littering sidewalks, large groups congregating, finding people sleeping or passed out along alleyways, in the streets and in front of homes. - 3. Establishing a homeless shelter or low-income public housing site close to another Community Council's area, may adversely impact those residents and businesses near the shelter or housing site. The FBI's Uniform Crime Reporting (UCR) Program has mapped areas of burglaries and determined that most burglars have been found to strike homes within a few miles of their residence.

- 4. The use of a 1.5 mile radius is subjective at this point and should be discussed and selected based on available studies of crime relative to shelters/low-income housing and/or perp residency. Crime statistic studies show the burglary victim/perp residency range to be 1-2 miles, therefore, it may be reasonable to use a 2-mile radius instead of 1.5 mile.
- 5. Community Council boundaries are reviewed and sometimes altered every 10 years, further impacting neighborhoods around where shelters or public housing are placed. For example, the area north of Klatt Road to Minnesota Drive and west of the Seward Highway, is currently part of Bayshore/Klatt CC area. That area is recommended for annexation into the Old Seward/Oceanview CC area under the latest 10 year review of CC areas.

2. INDIVIDUAL POSITION STATEMENTS FROM EACH DISTRICT 6 COMMUNITY COUNCIL

A. Based on discussions held at District 6 CC meetings this summer, it is evident that there are minor differences of opinion concerning the need for, types of, and suitable placement of one or more possible homeless shelters and/or low-income public housing in South Anchorage.

- B. While an overall position statement is being written for District 6 regarding homeless shelters and low-income public housing, it is recommended that each District 6 CC draft and submit an individual position statement to be included with the District 6 position statement package. Individual District 6 CC position statements should:
 - i. Briefly state that CC's position regarding the nomination and establishment of a homeless shelter and/or low income public housing in District 6,
 - ii. The rationale for the stated position,
- iii. The measures taken to establish the stated position (e.g., surveys of residents and businesses).
- iv. It is recommended the individual District 6 CC position statement's be no more than two paragraphs in length.







Hello Kyle,

Yes, we (ADOT&PF Bridge Section) are aware of the active streambank/guidebank erosion upstream of the pedestrian bridge crossing Glacier Creek in Girdwood. The pedestrian bridge is located upstream (north) of the Alyeska Highway bridge. We have been coordinating internally (ADOT&PF Central Region Utilities, Environmental, Hydraulics and Maintenance and Operations staff), and externally (USGS, AWWU and CEA) on monitoring of, and response to, the erosion.

We are currently working on permitting for a streambank/guidebank repair to replace the riprap that was armoring the guidebank located upstream and east of the pedestrian bridge. The proposed repair project would restore the riprap armor in the same configuration as was originally placed during bridge construction, but with a larger class of riprap to provide additional erosion resistance. The approximate length of the proposed riprap repair is to ~100 feet upstream of the pedestrian bridge. Funding is not available to conduct the repair until summer 2024. The current plan is to conduct the repair as early as possible during summer 2024.

There are currently no plans for bridge replacement at Glacier Creek, only the proposed repair to the streambank/guidebank discussed above.

FAQ - Property Tax Exemption for Volunteer Firefighters and EMS Personnel

The details of the Ordinance would be determined by the Anchorage Assembly, but here are some notes on how it could be structured

- At least two other Alaska boroughs enacted a property tax exemption for current and active volunteer fire fighters and EMS service providers.
 - Fairbanks North Star Borough <u>FNSB code 8.04.060 N</u>
 - O Kenai Peninsula Borough KPB code 5.12.113
- Property tax exemption amount is \$10,000 of the appraised value or up to \$20,000 when two or more resident owners are qualified volunteers, with a maximum 20% of appraised value
 - this is in addition to other residential exemptions
- The exemption would apply to property owners across MOA, not just in Girdwood, and to volunteer members of either Chugiak and Girdwood volunteer fire departments.
- The Chief of each volunteer department would certify which members are "current and active" each year
- The exemption would not change the overall amount of tax collected, but would result in a slight change to MOA tax rates.
- While the Assembly can create the ordinance, it would likely require passage of a ballot question for all voters in MOA election

For example, the KPB code defines "active volunteer" to include those receiving "on-call" compensation only.

"Active volunteer" means a person meeting the training, response, and participation criteria as established by each recognized first responder service, registered fire department and/or state certified ambulance service. The criteria established by each department that defines "active volunteer" shall be on file with the Kenai Peninsula Borough assessing department. Persons serving "on-call" who are not regular borough employees as either a firefighter or emergency medical services provider shall be eligible for consideration as an active volunteer if all other criteria are satisfied.

Resolution 2023-17 Of the Girdwood Board of Supervisors Support for a Property Tax Exemption in the GVSA for Volunteers serving Girdwood Fire Department

WHEREAS, volunteer fire departments provide critical public safety services to many non-urban communities across the state of Alaska and across the nation; and,

WHEREAS, the Anchorage Fire Department (AFD) is the public safety department responsible for providing emergency response to the citizens and visitors of Anchorage, providing fire services across most of the Anchorage Bowl and much of Eagle River, with EMS coverage extending throughout the 1,961sq miles of the entire Municipality of Anchorage (MOA); and,

WHEREAS, the Municipality of Anchorage has two volunteer fire departments within its boundaries, namely Chugiak Volunteer Fire and Rescue Company (CVFRD), serving the communities of Chugiak, Peters Creek and Eklutna, and Girdwood Volunteer Fire and Rescue (GVFR) serving the Girdwood and Turnagain Arm region; and

WHEREAS, the community of Girdwood is located over 30 miles from the closest AFD Fire Station 9 in Anchorage; and,

WHEREAS, Mutual Aid agreements exist between the AFD, GVFR and CVFRD, and others; and,

WHEREAS, Girdwood Fire Department was originally established in 1959 to provide fire protection in Girdwood Valley and took on responsibility for Emergency Medical Services in 1974; and,

WHEREAS, Girdwood Volunteer Fire and Rescue was incorporated in 1998 as a member run non-profit organization to provide fire, EMS and rescue services in the Girdwood and Turnagain Arm region under contract with the Girdwood Valley Service Area (GVSA) and the Municipality; and,

WHEREAS, retention of qualified volunteers continues to be a challenging aspect of managing a volunteer fire and EMS department; and,

WHEREAS, significant time and taxpayer funds are allocated to the recruitment and training of volunteers to meet and maintain state qualifications, so it is in the fiscal interests of both the GVSA and the Municipality to retain qualified volunteers; and,

WHEREAS, other Alaskan boroughs, including Fairbanks North Star and Kenai Peninsula Boroughs, have established a property tax exemption for volunteer fire and EMS personnel to acknowledge the significant investment of time and energy these community members make to their fellow citizens; and,

WHEREAS, at their August 29, 2023 meeting, the GVFR Board of Directors passed a resolution of support for a property tax exemption for creating a property tax exemption for current and active volunteers;

THEREFORE, the Girdwood Board of Supervisors recommends that the Municipality adopts policies to encourage retention of qualified volunteer firefighter and emergency medical providers, both to acknowledge the critical service such volunteers provide to our community and as good fiscal policy,

ALSO THEREFORE, GBOS requests that the Anchorage Assembly establish a property tax exemption for current and active volunteers of a registered fire department operating within the Municipality, modeled on similar exemptions in Fairbanks North Star and Kenai Peninsula Boroughs, by amending AMC 12.15.015.E and prepare an associated ballot proposition on the 2024 Municipal election.

Luke,

Thank you for the quick reply and update. I'll share this with GBOS and the public at the next meeting.

A couple of follow-up questions:

 Is there any concern by ADOT about the potential failure of the Pedestrian and vehicle bridges if erosion continues before repair next summer? As well as the utilities (AWWU, CEA, Telecoms) in this location. Fall typically produces our most significant and damaging storms of the year.

Yes, we are concerned about the progression of the streambank/guidebank erosion, especially considering the typical peak flow drivers for Glacier Creek (fall precipitation and spring runoff). We (Bridge Section) continue to monitor the USGS stream gage and flood forecasts for Glacier Creek. We have asked our local DOT M&O crews and adjacent utility stakeholders to continue monitoring the streambank/guidebank erosion and bridges/approach embankments and communicate observations to us. Please let DOT&PF know (both local M&O and this email group) if you observe or get reports of streambank/guidebank erosion progression or changes at the bridges and/or approach embankments (settling, cracks/potholes/voids forming in the roads/pedestrian paths adjacent to the bridge). We are continuously evaluating the risks to the bridges and approach embankments (primarily the pedestrian bridge, but also the Alyeska Highway bridge if the erosion progresses) based site observations and flood forecasts.

2. Will ADOT need community support to seek funding, as it is not currently available?

Expressed concern from community members can sometimes expedite action, particularly in emergency situations. Generally, we very much appreciate hearing from community members about what they are seeing in the field because they see problems developing before we do. For this present erosion concern, ADOT&PF Central Region M&O is aware of the issue. Looking forward, there are federal grants available to improve 'resiliency' and to protect infrastructure, and to be competitive for those grants, it is helpful to have the formal support from local communities. I do not think we can hold out for a federal grant before addressing the erosion situation at Glacier Creek, but I share that funding opportunity as a potential path for future problematic sites.

3. Where does the funding come from for the repair?

Good question. We hydraulics engineers do not typically get involved in the project management activities, such as determining funding sources. Rather, we provide scoping recommendations and design support. For answers on potential funding sources, particularly in emergency situations, I recommend contacting Burrell Nickerson, ADOT&PF Central Region M&O Manager (cc'd).

I am just trying to get prepared for questions I'll get from the community when I provide them an update. I regularly get residents calling with questions and concerns. Most just want to tell me about it and if I was aware, which can be a real test of patience.

Hello Kyle,

Yes, we (ADOT&PF Bridge Section) are aware of the active streambank/guidebank erosion upstream of the pedestrian bridge crossing Glacier Creek in Girdwood. The pedestrian bridge is located upstream (north) of the Alyeska Highway bridge. We have been coordinating internally (ADOT&PF Central Region Utilities, Environmental, Hydraulics and Maintenance and Operations staff), and externally (USGS, AWWU and CEA) on monitoring of, and response to, the erosion.

We are currently working on permitting for a streambank/guidebank repair to replace the riprap that was armoring the guidebank located upstream and east of the pedestrian bridge. The proposed repair project would restore the riprap armor in the same configuration as was originally placed during bridge construction, but with a larger class of riprap to provide additional erosion resistance. The approximate length of the proposed riprap repair is to ~100 feet upstream of the pedestrian bridge. Funding is not available to conduct the repair until summer 2024. The current plan is to conduct the repair as early as possible during summer 2024.

There are currently no plans for bridge replacement at Glacier Creek, only the proposed repair to the streambank/guidebank discussed above.



On or before September 1 of each year, the Municipal Clerk is required to notify all Community Councils of liquor licenses located within their boundaries that will be reviewed by the Assembly for the upcoming liquor license renewals (AMC 2.30.120C). To comply with this provision of the code, the Clerk's Office has attached a spreadsheet of the 2024-2025 liquor licenses which are anticipated to submit renewals and are sorted by community council for ease of review.

Public Hearings and Resolutions:

The Municipal Clerk is also required to advise Community Councils that they may request a legislative public hearing before the Assembly on any liquor license renewals within their boundaries (AMC 2.30.120C). To request a public hearing, the Community Council must adopt a resolution asking the Assembly to hold a public hearing on the liquor license renewal and must send the resolution directly to the Office of the Municipal Clerk at munilicenses@anchorageak.gov.

The request for a public hearing should be in the form of a resolution and preferably containing the following information: Number of community council member votes in favor of the request and the number of votes opposed; specific facts, including dates; and supporting documentation. <u>The resolution must be received no later than October 15, 2023</u>.





Our crew, along with Friends of Girdwood Trails, has been working on the Middle

Iditarod National Historic Trail, to uncover the historic alignment and improve access with new bridges. Middle INHT is our planned project for an RTP grant 2024-2026.

They also built an additional bridge on Abe's Trail and added netting to it and the one previously build with the help of the Methodist mission group.

GTC, Friends of Girdwood Trails and Parks and Rec message of the month is regarding invasive weeds, particularly Bird Vetch and others that can be pulled and disposed of safely. Don't pick Orange Hawkweed! Picking Orange Hawkweed stimulates growth! Report new Orange Hawkweed locations to Parks and Rec tylerms@muni.org and we will advise our weeds contractor.



We encourage all trail users to be wildlife aware this fall. Make noise and keep a safe distance from wildlife. As always, pick up dog poop and dispose of it properly.

Trails: GTC returned to meetings in early August after taking June as a work party and July as a break. September meeting focused on the Winner Creek Trail Bridge over Glacier Creek.

GVSA will re-apply for Rasmuson Foundation funding when appropriate and will seek additional funds to complete the project and interpretive display.

Trail Maps: GTC and staff are working on new trail maps. Goal is to have mapping available in print, on-line and maps that reflect seasonal trails posted at main trailheads.

Trails Plan: Blueline Candidate draft of the Girdwood Trails Plan received HLBAC review and support in May. Plan application has been submitted to next moves to Planning and Zoning, aiming for approval this fall. The document is available for review here Municipal Road Maintenance Service Areas Girdwood Trails Plan

Parks & Amenities: No dogs on the baseball field, playground, tennis courts, and skate park.

- *Campground:* Kira and Jared are overseeing the campground thru September. Campground is impacted by overflow of California Creek and is now closed.
- Annual Beautification: Wow! It's Year of the Nasturtium! We'll keep the flowers going as long as we can.
- *Playground:* Open. Needs wood chips and sand in 2023. Currently unable to get playground quality wood chips for this project.
- Lions Club Park: Working on a plan to add a pavilion to the Lions Club Park
- Disc golf: Open.

Roads

Road Status: Many large projects have been completed in July and August, along with standard maintenance of grading roads, dust control, and cleaning out existing drainages. Several more projects will be completed in September and into October, depending on the funding availability and weather.

Major project updates:

Ruane road fish passage culvert replacement. We've located the funding for this project along with AWWU funding for Girdwood improvements being managed by the EPA. We must apply with the EPA to request the funds and coordinate that effort with AWWU. The funding designated for the project is \$1.6 million, and it will require a 20% match.


