Old Business:

Agenda Item LUC 2502-05: Request reconsideration vote re LUC April 2025 recommendation for GBOS Resolution of Support for code change to allow retail in gC-10, Tract B2A, Alpine View Estates, Phase 3 (Tim Cabana, presenting).

Brice Wilbanks notes that he was unclear of what was being voted on at the LUC meeting in April. Vote didn't follow Roberts Rules – Proposed motion was not formally amended but was passed as amended. Additionally, throughout the public process the request of the petitioner changed without supporting documents presented for consideration. The result was a confused group unclear of what they were voting on. GBOS moved forward with action despite being advised of the confusion at LUC. Wilbanks raises Point of Order and suggests a motion to reconsider. Concern is about the process not the project, chair acknowledges those concerns. Reconsideration vote would require motion by someone on the prevailing side; such motion is suggested by Wilbanks but no motion is made.

Agenda Item LUC 2403-04: Status of the Girdwood Comprehensive Plan and Heritage Land Bank 1 and 5 year plans (Imagine!Girdwood).

Girdwood Comprehensive Plan adopted April 22 by the Anchorage Assembly and is now in force. Celebration planned for 6PM at Girdwood Brewing Co Wed 5/14/25.

HLB plan work session held last week. Assembly Member Johnson plans to bring amendment to the 1 and 5 year plans at the May 20 meeting addressing the land north of the airport. Recommendation from assembly attorney is that conditions to land transfer should be handled through HLB via the work plan. Recommendations currently in Appendix 5 in the GCP would be added to the HLB Work Plan.

Agenda Item LUC 2407-04: Status of LUC recommended GBOS Resolution of Support for Service Area STR registration and regulation. (Wilbanks/Schechter/Edgington)

Municipal Manager has indicated that ordinance for STR registration is in the works and should be available for public review shortly. Girdwood could push forward our own ordinance however the two will need to have some consistency; recommendation by Edgington is to review the language provided by the MOA and determine changes to that to meet Girdwood needs.

New Business:

Agenda Item LUC 2504-04: Transit Supported Development (TSDs) LUC recommendation for GBOS Resolution of Support (TBA) Proposal for TSD in Anchorage wouldn't apply to Girdwood as-is, although some of the items in TSD are represented in Girdwood. Question for Girdwood committees (LUC and/or GHEC) is if they want to identify and support ideas considered in Anchorage that are consistent with Girdwood development goals, such as Transit Supported Development. LUC typically has commented only on items within Girdwood area. Lisa Miles states she will carry this forward to GHEC to discuss options and consider action. Wilbanks proposes a motion to postpone this item indefinitely at LUC, however it is new business. Action can be taken at a future meeting.

Agenda Item LUC 2505-04: Marijuana license renewals 2025. Objection to licenses within the GVSA must be provided by resolution no later than June 1 2025. If no objections exist, staff request for Letter of Non-Objection for License #M19277 Retail Marijuana Store The Herbal Cache, expiring 8/31/25.

Anyone having objections should make them known so that action can be taken. If no objections are raised, Letter of Non-Objection will be recommended.
