

# MINUTES Draft Girdwood Trails Committee Regular Meeting Tuesday, August 2, 2022 7:00PM

Girdwood Trails Committee meetings are taking place on Teams and in person at the Girdwood Community Room.

GTC Voting members are defined as is any person eighteen (18) years of age or older who has attended one or more Trails Committee meetings in the last 12 months, and is:

a) a current resident and/or property owner, business owner or designated representative of a non-profit association; and

b) who has resided in, owned property in, owned a business located in, or operated as a non-profit association for the preceding ninety (90) days or longer in Girdwood Valley.

Attendance is verified through a sign-in sheet available at each meeting, or equivalent process.

The Girdwood Board of Supervisors, its committees, and subcommittees are subject to the Alaska Open Meetings Act as found in Alaska Statute 44.62.310 and Anchorage Municipal Code1.25 - Public Meetings.

The Girdwood Trails Committee operates under the Girdwood Public Meetings Standards of Conduct.

**Introductions:** All attending are asked to introduce themselves for attendance tracking. **Returning/New members are:** Amanda Locke, Leola Rutherford, Kelzey Hahn **Public Comment (3 minutes each)**: Public Comment must be on subjects not listed on the agenda. #### **Old Business:**

1. Girdwood Trails Plan

Continue presentation and voting on GTC member suggested changes to GTP meeting, starting at Amendment 7.

Amendment 7: Proposed Motion: Amend the approved recommended change of Natural Spaces description on P 35, **Areas For Primitive Trails** by adding the following sentence: Primitive Trails should be routed or rerouted onto sustainable alignments and hardened when necessary to assure trail sustainability.

Group discusses that this action should not be necessary as the Trails Class system specifies that Class 1 or 2 trails are still maintained trails and allows for boardwalks, hardening, re-routing to protect the environment. This could also be considered more of a Trails Management Plan item. Crews is asked if he would like to pull his amendment in the light of this, however he states that the misunderstanding about maintenance of Class 1 and 2 trails persists and clarification the Trails Plan is necessary.

Motion:

GTC moves to accept Amendment #7: Adding the following sentence to Pg 35: Primitive Trails should be routed or rerouted onto sustainable alignments and hardened when necessary to assure trail sustainability Motion by Paul Crews/2<sup>nd</sup> by Brian Burnett Total is 26 in favor, 16 opposed, 4 abstain Motion carries

Amendment #8:

Proposed Motion: Vote to remove all primitive trail areas from the maps.

Deb presents that she supports primitive trails and areas but they don't belong on the maps as the primitive area restricts use of mechanized vehicles and could limit access, particularly from the townsite to the mouth of the valley in Area 1. She is concerned that many small trails leads to braiding and degradation of the area, it would be better to plan for actual trail alignments rather than to set aside an area for less structured use.

Group discusses that Natural Spaces was renamed Primitive Areas at earlier meeting, expansion of Primitive Area 1 was discussed at an earlier meeting. However voting on their existence has not been considered yet by the GTC as a whole.

Members states that if primitive areas are removed, perhaps Mountain Bike Areas in the plan should also be removed.

Motion:

GTC moves to accept Amendment 8: Remove all Primitive Areas from the maps. Motion by Deb Essex, 2<sup>nd</sup> by Brian Burnett Total is 30 in favor, 18 opposed, 5 abstain Motion carries

Set meeting date for GTC Special Meeting.

Group is looking at MON Aug 29 at 7PM, however parliamentarian is not available. Meeting is scheduled for <u>MON Aug 22 at 7PM</u>.

2. Discussion regarding addition of parliamentarian to assist in meetings Discussion pending the individual who proposed it attending the meeting to help with discussion and research with UAA to see if there may be help from UAA debate students. Item is postponed.

- 3. Trails Issues
- Glacier Creek Suspension Bridge status: \$1.2M from State of Alaska. Currently in design phase with USFS support. USFS plans to take over operation and maintenance after construction. Design team to have on-site visit in September, planning for full design mid-winter and plan for construction in 2023.
- Virgin Creek Falls Trailhead re-route & interpretive sign (Kyle Kelley) Andy Hehnlin completed trailhead work last week, AK Trails has crew that will help spread gravel to the falls in September. Interpretive sign is ready to be installed.
- Update on Stumpy's Winter Trail Interpretive sign project (Barb Crews) Sign is complete and ready for installation. Location is likely where the trash can has been. Trash location is moving.

## Summer trails issues:

Commercial use of Girdwood Trails, especially Virgin Creek Falls, is being addressed by contacting companies and advising of the need for permit to legally use the area. Staff is working with MOA traffic regarding parking and traffic concerns, including speeding.
