3. Holtan Hills Development Phase 1 CU/PUD and Middle Iditarod National Historic Trail reroute (Brian)

Mike Edgington attended the Planning and Zoning Commission meeting on MON Jan 5. Result of trails items at P&Z was that CY Investments will pay for realignment of the trail and trail easement through Phase 1 of the Holtan Hills Development.

Actual language of this will be presented at P&Z next meeting for final review and vote.

4. Update on Winner Creek Trail Bridge at Glacier Creek  
Project is planned to go out to bid in January for construction as designed and approved by GTC and USFS. Letter received from USFS regarding collaboration with MOA on the project has been received. Once constructed, the bridge will be turned over to USFS for operation and maintenance. Design meets USFS requirements. Once bids have been received, firm budget will be known for this mainly steel construction project. Capital campaign may be initiated to fill any gaps.
5. Consider Community Trails Info message for upcoming month to be shared on social media  
Additional snow needed before grooming in meadows will begin. Storm later this week should provide this additional coverage. There will be challenges with the ice buildup in some overflow locations due to long duration of cold weather without snow coverage.
6. Girdwood Trails Management Plan Revision and Review  
Appendices 5,6,7 were discussed in December and amended for this meeting.

Introduction of Appendix 8, which catalogs all land management agreements and easements.  
Status of Appendix 1 (maps) and Appendix 2 (list and descriptions of trails): These two appendices are pending.

7. Girdwood Comprehensive Plan RE Parcel 6-011 and Upper Valley Trails  
Item is addressed in HLB 5 year plan. Plan has been approved by HLBAC and is moving forward to Assembly for introduction in January with likely Assembly approval in February.
8. GTC application for National Forest Foundation Matching Awards Program (MAP) Grant for MINHT work. Project is continuation of Middle Iditarod National Historic Trail work, which is an established and on-going project of GTC.
