Project: PRC 24-05: Youth Employment in Parks 2024 Projects

INTRODUCTION

Youth Employment in Parks (YEP) is a joint program of the Anchorage Park Foundation and the Municipality of Anchorage's Parks & Recreation Department. Since 2007, YEP has hired over 475 Anchorage youth to complete park improvement projects resulting in millions of dollars of improvements to Anchorage Parks and Trails.

YEP aims to engage a new generation of young leaders in the conservation of public lands through meaningful job training, employment, and education. A major component of the YEP program is education and civic engagement. Through the course of the ten-week program, YEP teens learn about environmental stewardship, natural resource conservation and land management. Each week, the YEP program sponsors an education day and at the end of the program teens participate in a mentorship week that links their new skills to future careers.

Last year, the Youth Employment in Parks teens completed \$170,000 worth of improvements in Anchorage Parks and Trails. This summer, the YEP teens will complete an additional \$270,000 in improvements in Anchorage Parks.

PLANNING AND PUBLIC INVOLVEMENT

Youth Employment in Parks projects receive input from the community and guidance from Parks and Recreation staff to ensure that park improvements are consistent with the goals of the (2006) *Anchorage Bowl Park, Natural Resource and Recreation Facility Plan.* Parks and Recreation staff has also worked closely with government agencies and non-profit partners to identify projects that capitalize on available funding and achieve mutually beneficial outcomes.

YOUTH EMPLOYMENT IN PARKS (YEP) 2024 PROJECTS

Wesleyan Connector Trail Improvement

\$1,000

Youth Employment in Parks will improve a 200 foot connector trail between Wesleyan Dr and the asphalt bike trail near University Lake Park.

KFQD Bike Skills Loop

\$15,000

Youth Employment in Parks will construct a 300 foot bike skills loop at KFQD Park. The bike skills loop will consist of gravel and be approximately 4-6 feet wide. Bike features, such as rollers, bank turns, and other features.

Cuddy Family Park Rain Garden and Vegetation

\$170,000

Youth Employment in Parks will construct a rain garden at Cuddy Family Midtown Park. This rain garden will include native plants and trees, as well as mulch and a gabion retaining wall. This rain garden will help improve water quality in Cuddy Pond. YEP will also plant many additional natives shrubs around Cuddy Pond to help with erosion issues. Temporary fence will constructed to help protect the newly revegetated areas.

Hillstrand Pond Bank Restoration and ELP

\$13.000

YEP teens will work along Chester Creek at Hillstrand Pond to perform a bank restoration project. Teens will plant native plants and shrubs along the bank of Hillstrand Pond, including three 50 foot layers of willow trenching. A 24 ft x 5 ft Elevated Light-penetrating Platform (ELP) will also be installed for wildlife viewing, while protecting the reestablished shoreline. Temporary fence will be installed to protect the new plantings and restoration.

MOA Greenbelt Tree Planting

\$15,000

The Parks and Recreation Department was awarded a Urban Forestry Grant to help replant trees lost to the spruce beetle. The YEP crew will perform one week of planting trees along MOA Greenbelts to help replace the forest canopy. Teens will plant over 1000 trees throughout this greenbelt.

Ship Creek Bank Restoration

\$36,000

YEP teens will work along Ship Creek to help improve a bank restoration project. Teens will plant native plants and shrubs along the bank of Ship Creek. Temporary fence will be installed to protect the new plantings and restoration.

Government Hill Trail Improvements

\$20,000

Youth Employment in Parks will perform approximately a half mile of trail improvements in Government Hill. Gravel will be added to existing trail. In addition, new wooden steps will be constructed as well as other wooden structures. Teens will improve drainage and tread along this trail between Sunset Park and Alderwood Park. Crews will add gravel and drainage features along these trails and improve sightlines throughout the park for improved safety.

STAFF RECOMMENDATION

The proposed Youth Employment in Parks projects have been reviewed and are supported by Park and Recreation Department staff. The Department recommends that the Parks & Recreation Commission pass the proposed resolution in support of the Youth Employment in Parks projects as presented.

PRC RES NO. 2024-05 Youth Employment in Parks - 2024 Projects

WHEREAS the Youth Employment in Parks (YEP) is in its 18th year of operation with a planned scope of work that includes trail work, bank restoration, slope stabilization, landscaping and vegetation rehabilitation, and park beautification projects to be completed during the 2024 YEP program season; and

NOW THEREFORE BE IT RESOLVED, that the Anchorage Parks and Recreation Commission approves the scope of work submitted by the Department for the 2024 Youth Employment in Parks Projects.
