#### **ACTION ITEMS**

PRC 25-04: Nunaka Valley North
PRC Resolution 2025-04
Presented by Melanie Hess

Melanie, Anchorage Parks and Recreation Park Planner, presented the Nunaka Valley North Park (NVN), playground, and athletic court upgrade. Acquired in 1974 5.4 acre neighborhood park. Proposed to add new equipment (some will stay that is in good condition) within existing footprint with accessible surfacing, add pickleball striping on two existing tennis courts (painting done by volunteers, paint paid for by parks an rec). Funding from SOA legislative grant and from voter approved bonds for inclusive play. Existing conditions: Large composite wood structure that has been partially decommissioned because it has been deemed unsafe. Had assessment in 2018 State of Play analysis of all playgrounds in Anchorage to see how inclusive and assessable

they are to people of varying abilities. NVN was assessed at a 4, which is the lowest. Started out with public online survey (Nov 24-Jan 25), kicked off at Community Council. Proposals from 4 playground designers to stay in budget and footprint. Results of Survey outcome: overall preference Zip and Dip, Zipline, spinner, extend assessable surface to swings, and add port-a-potty. Concept presented at community council. The goal is to finish this summer.

# PRC 25-05: Report on Oulu and Helsinki Urbanism Master Class

Presented by Nicolette Dent (Planner), Tanya Hickok (Civil Engineer & Planner), Desireé Wilson (Parks Foreman), Stephan Stonerock (Operations & Maintenance General Foreman)

Nicolette Dent, Anchorage Parks and Recreation Park Planner, along with a group that included someone from every aspects of planning, building, and maintaining trails went Cycling Superhighway in Finland.

Why: 1997 Areawide Trails Plan-Updating w/funding from AMATS (Federal Highway Admin) - Create modern guide on how we build, manage, and maintain trails in the MOA. Includes funding for update and training.

Plan Goals: Connectivity, Safety, Quality, Wellness, Variety of user groups

Training Overview: Internationally known for cycling superhighway design and similar to Alaska climate. Helsinki-Urban Oulu-Suburban (similar size to Anchorage)

Des: Oulu lives revolve around cycling, well-lit trails, multi-use (cycling and pedestrian only), world's largest underground bike parking next to train station, Rode on Baltic Sea. Ski trails are only ski trails. Maintain trails similar to us.

Cycling Superhighway Design (Tanya): 6.6m wide superhighways....about double ours. Two directional cycling lane. Lane width are based on traffic counts, typically located away from arterial roads. In Helsinki, they have grade separations between pedestrian and cycling lanes.

Winter Maintenance Process (Stephan): Summertime-Oulu is broken down into 10 zones; each has its own private contractor. In winter there is an 11<sup>th</sup> crew that maintains entire superhighway (6 maintenance routes, 6 drivers). 150 volunteers rate trail conditions and this directly informs contractor bonuses. Contractor is required to host public pop-up event for feedback. As well as the city. Trails are split into three classes: Super, 1. Class, 2.Class. Super is top priority and must be cleared within 3 hours once 2 cm snow and cannot exceed 4cm. All routes use carbonite front blade and snow blower, blade teeth provide traction. Did not ride fat bikes.

Takeaways for Anchorage Trails: How does this apply to Anchorage? Perfect time, in the midst of updating our trail plan. Think about where we need to widen our trails. Through our surveys and trail workshops we hear people are concerned about increased traffic, e-bike speeds, Westchester, Coastal Trail. Will be updating our trail classifications and trail design standards. We have the opportunity to see what a wider trail would look like in Anchorage. how our greenbelts need to evolve over the next 20 years to accommodate all users. Maybe try out new blades and see how users like it. Improving trails improves the health of residents.
